REQUESTED ACTION:

Approve the First Amendment to Agreement for the above-referenced Request for Proposal (RFP). Contract Term; January 1, 2019 through June 30, 2019, 6 Months; User Department: Office of Financial Services; Award Amount: \$275,000; Awarded Vendor(s): Gallagher Benefit Services, Inc.; Small/Minority/Women Business Enterprise Vendor: S, Davis & Associates, P.A.

SUMMARY EXPLANATION AND BACKGROUND:

The contract for RFP 16-017V - Consulting Services for Employee Benefits Program was awarded to Gallagher Benefit Services, Inc. on August 18, 2015, The term of the initial contract period was October 1, 2015 through December 31, 2018, with an option for two (2) one (1) year renewals.

EXECUTIVE SUMMARY

First Amendment to Agreement and Renewal 16-017V – Consulting Services for Employee Benefits Program

Introduction Procurement & Warehousing Services (PWS)

This request is to approve the First Amendment to Agreement and Renewal for Request for Proposal (RFP) 16-017V – Consulting Services for Employee Benefits Program for a period of six (6) months from January 1, 2019 through June 30, 2019. This RFP provides services to the Benefits Department assisting with the development of RFPs under Florida Statute Section 112.08, analysis and design of benefits plans, including Internal Revenue Code Section 125, coupled with assistance in plan document drafting.

Goods/Services Description Responsible: Office of Financial Services

A draft RFP 16-002V, Employee Benefits Insurance Consultant Services, was developed and subsequently reviewed in a public meeting by the Superintendent's Insurance & Wellness Advisory Committee (SIWAC) on October 9, 2014. The RFP was released through the Onvia DemandStar system on November 24, 2014. Subsequently, the School Board received one (1) proposal in response to the RFP from Gallagher Benefit Services, Inc.

Upon receipt of the sole proposal, an addendum was released on January 7, 2015, stating in part, "If only one (1) responsive proposal is received, the Committee will proceed without scoring the one responsive proposal and may negotiate the best terms and conditions with that sole proposer or may recommend the rejection of all proposals as permitted by Section 6A-1.012(12)(c), F.A.C."

On February 18, 2015, the School Board approved Board Item EE-5 to reject all bids for RFP 16-002V. The summary also informed the School Board that staff would conduct a vendor workshop, revise the RFP, and bring forth a follow-up item to extend the current contract with Gallagher Benefit Services, Inc., by ninety (90) days and to request additional spending authority for the extended period (until such time a new RFP would be released, proposals evaluated, and a recommendation to award a new contract could be submitted to the School Board). On May 19, 2015, the School Board approved Board Item EE-1 extending the contract and authorizing additional spending authority to allow for the re-release of the RFP.

In an effort to increase competition, respond to vendor questions, provide information and/or clarification, and to obtain feedback on the previously released RFP, PWS staff contacted numerous potential vendors via e-mail and telephone and inquired as to why they did not submit a Proposal, as well as invited them to attend a Pre-bid Conference. The Pre-bid conference allows potential vendors to comment on the contents of the previously released RFP and ask questions. The Pre-bid conference was held on Wednesday, March 25, 2015, at the TSSC Building from 9:30am-11:00 am; only one (1) potential vendor attended the meeting.

Based on feedback received, and a review by PWS & Office of Financial Services staff, the RFP was revised prior to its re-release on April 23, 2015. Staff from PWS contacted potential Proposers to alert them to the re-release of the RFP. Proposals were due on May 19, 2015; one (1) Proposer Gallagher Benefit Services, Inc., submitted a response to the RFP.

As permitted by Section 6A-1.012(12)(c), F.A.C., the SIWAC entered into negotiations with the sole Proposer, Gallagher Benefit Services, Inc. on June 4, 2015, based on the scope of services, cost, and small/minority/women participation. As a result of the negotiations, SIWAC voted to recommend to the Superintendent the following award: Gallagher Benefit Services, Inc.

On August 18, 2015, the contract for RFP 16-017V - Consulting Services for Employee Benefits Program was awarded to Gallagher Benefit Services, Inc. The initial contract period is October 1, 2015 through December 31, 2018, with two (2) one (1) year renewal options.

On May 16, 2018, and June 13, 2018, the SIWAC held its annual contract renewal meetings. On June 13, 2018, the SIWAC voted unanimously to recommend approval of Gallagher Benefit Services' first one (1) year renewal option to the Superintendent of Schools. During the meeting Gallagher Benefit Services agreed to hold their rates flat for calendar year 2019; therefore, there is no additional cost impact to the School Board for 2019.

Gallagher Benefit Services, Inc. is a subsidiary of Arthur J. Gallagher & Co.; has more than one hundredeighty (180) offices throughout the United States, is highly respected in the marketplace and is the largest governmental consulting firm in Florida. One (1) of Gallagher's primary focus is the K-12 market, providing expertise in the development and design of Employee Benefits Plans to their School District clients.

To date, Gallagher Benefit Services, Inc. is contracted with over eight hundred-fifty (850) clients in the Public Entity and Scholastic fields. Of those, fifty-three (53) percent represent counties and other governmental clients. Upon approval of this agenda item, the School Board and its employees will benefit from their expertise in the market and their understanding of The School Board of Broward County, Florida, objectives of lowering both School Board and employee cost, while providing high-value benefits to District employees.

Procurement Method Responsible: PWS

The procurement method chosen is through a competitive solicitation, which is required by School Board Policy 3320, Part II, Rule D and Florida Administrative Code 6A-1.012(7). This solicitation was released to the public from April 23, 2015 through May 19, 2015, where four-hundred and twenty-five (425) vendors were notified, twenty-one (21) vendors downloaded the RFP documentation. PWS received only one (1) proposal. The proposal received was submitted by Gallagher Benefit Services, Inc.

Small/Minority/Woman Business Enterprise Participation

Gallagher Benefit Services, Inc. will be utilizing a certified Small/Minority/Woman Business Enterprise subcontractor, S. Davis & Associates, P.A., as needed, who will review Financial Statements provided by Proposers to determine whether the information submitted has been audited, in order to meet minimum qualifications of the RFP and equals approximately \$5,000 under this contract.

Financial Impact Responsible: Office of Financial Services

Gallagher has agreed to hold its rates flat for 2019; therefore, the total spending authority requested for 2019 is a flat rate of \$275,000 and therefore does require an additional financial impact to the School Board. The funding for this contract will come from the Fringe Benefits Clearing Account.

Next Steps

Responsible: PWS and Office of Financial Services

In anticipation of releasing an RFP in the next several months, PWS and Office of Financial Services conducted extensive preliminary research and outreach to potential vendors that would possibly be interested in responding to a future Benefits Consulting solicitation. The market canvassing included analysis of neighboring school district's solicitation requirements, bid responses and those District's current Benefits Consultant, compared to Broward County Public Schools (BCPS), as well as identifying market leaders and local vendors that would be interested in providing "Benefits Consulting" services to the District.

A wide range of firms were contacted, ranging from the top ten (10) in world-wide ranking to smaller, but capable firms that may be able to deliver satisfactory service. This in-depth analysis will be utilized to determine how the District can potentially increase responses from qualified vendors to the future Benefits Consulting RFP and communicate the District's needs accordingly. PWS staff, along with Office of Financial Services staff will be conducting a Pre-bid Conference in an effort to respond to vendor questions, provide information and/or clarification and increase competition. PWS staff will release the Pre-bid Conference announcement via Onvia DemandStar, which will be held at the TSSC Building in or around November/December 2018. The release of the Benefits Consulting RFP will be targeted for January/February, 2019.

FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into as of this 7^H day of Overview, 2018, by and between

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "SBBC"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue Fort Lauderdale, Florida 33301

and

Gallagher Benefit Services, Inc. (hereinafter referred to as "GBS"), whose principal place of business is 2255 Glades Road, Suite 200E Boca Raton, Florida 33431

WHEREAS, SBBC issued a Request for Proposal, identified as RFP 16-017V -Consulting Services for Employee Benefits Program, dated April 23, 2015, and amended by Addendum One dated, May 11, 2015 (hereafter referred to as "RFP") which are incorporated by reference herein, for the purpose of receiving proposals for Consulting Services for Employee Benefits Program; and

WHEREAS, GBS offered a proposal dated, May 18, 2015, (hereafter referred to as "Proposal") which is incorporated by reference herein, in response to RFP, and;

WHEREAS, SBBC and GBS entered into an Agreement dated, August 18, 2015 (hereafter "Agreement") for Consulting Services for Employee Benefits Program under RFP 16-017V; and

WHEREAS, the Parties mutually desire to amend certain provisions of the Agreement.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

ARTICLES

1.01 <u>Recitals</u>. The Parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.

First Amendment to Agreement with Gallagher Benefit Services, Inc.

2.01 <u>Term of Agreement</u>. The term of this First Amendment to Agreement is January 1, 2019 through June 30, 2019.

3.01 <u>Cost of Services.</u> The annual fee for the period January 1, 2019 through June 30, 2019 is \$275,000, to be paid in monthly installments.

In addition, SBBC shall pay GBS the following hourly rates for special projects requested by SBBC, which fall outside of the negotiated scope of services of the Agreement:

Lead Consultant	\$270 per hour
Senior Consultant	\$250 per hour
Attorney	\$250 per hour
Consultant	\$170 per hour
Actuary	\$285 per hour

4.01 <u>Order of Precedence Among Agreement Documents</u>. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- a) This First Amendment to Agreement; then
- b) The Agreement dated, August 18, 2015; then
- c) Addendum Number One dated, May 11, 2015; then
- d) RFP 16-017V Consulting Services for Employee Benefits Program; then
- e) The Proposal submitted by GBS in response to the RFP.

In case of any other doubts or difference of opinion, the decision of SBBC shall be final and binding on both Parties.

5.01 <u>Other Provisions Remain in Force</u>. Except as expressly provided herein, all other provisions of the Agreement remain in full force and effect.

6.01 <u>Authority</u>. Each person signing this First Amendment to Agreement on behalf of either Party individually warrants that he or she has full legal power to execute this First Amendment to Agreement on behalf of the Party for whom he or she is signing, and to bind and obligate such Party with respect to all provisions contained in this First Amendment to Agreement.
