SUMMARY EXPLANATION AND BACKGROUND:

The School Board of Broward County, Florida, received two (2) bids for ITB 16-040H - Armored Car Service. The ITB was designed to facilitate the transfer of currency, coin, and check transfer. The armored car service will have scheduled pickups and deliveries from designated locations throughout the District. Food and Nutrition Services (FNS), the primary user, schedules daily pickups and deliveries (Monday thru Friday) for all school site cafeterias. Internal accounts pickup and deliveries occur on an as needed basis. All pickups shall be for deposits at the designated bank depository for each location.
