Why Third Grade Summer Academy?

Florida State Statute 1008.25 (7)(a)2.

- (7) SUCCESSFUL PROGRESSION FOR RETAINED THIRD GRADE STUDENTS.-
- (a) Students retained under paragraph (5)(b) must be provided intensive interventions in reading to ameliorate the student's specific reading deficiency and prepare the student for promotion to the next grade. These interventions must include:
- 1. Evidence-based, explicit, systematic, and multisensory reading instruction in phonemic awareness, phonics, fluency, vocabulary, and comprehension and other strategies prescribed by the school district.
- 2. Participation in the school district's summer reading camp, which must incorporate the instructional and intervention strategies under subparagraph 1.



Third Grade Florida Standards Assessment (FSA)


Since the start of FSA, BCPS has <u>DECREASED</u> Level 1s by 5 points AND <u>INCREASED</u> Levels 3 - 5 by 7 points. This trend is consistent year after year.



2018 Third Grade Summer Academy Instructional Staff Changes

Florida Statute 1008.25 (7)(b)3. Highly Effective Teachers

Provide students who are retained under paragraph (5)(b), <u>including</u> students participating in the school district's summer reading camp under subparagraph (a)2., with a highly effective teacher as determined by the teacher's performance evaluation under s. <u>1012.34</u>, and, beginning July 1, 2020, the teacher must also be certified or endorsed in reading.
