### SUMMARY EXPLANATION AND BACKGROUND:

The District has a long-standing relationship with the South Florida Institute on Aging, Inc. (SoFIA) for the Foster Grandparent Program. The Foster Grandparent Program agreement was executed on June 13, 2017 through June 30, 2020. The revisions for the amendment are (1) the name change from Impact Broward, Inc. to South Florida Institute on Aging, Inc.; (2) the change in SoFIA's address; and (3) the change to specify the annual allocation of funds. This Amendment has been reviewed and approved as to form and legal content by the Office of the General Counsel. The Amendment will be signed by SoFIA after School Board approval.

## **EXECUTIVE SUMMARY**

First Amendment to Agreement with South Florida Institute on Aging, Inc. for the Foster Grandparent Program

For over 50 years, the South Florida Institute on Aging and Broward County Public Schools (BCPS) have worked together to help our community's children.

Volunteers in SoFIA's Foster Grandparent Program (FGP) serve Title 1 elementary school children with special needs for a minimum of 15 hours per week to improve reading, social and emotional development. The FGP volunteers are recruited and trained by SoFIA and must be cleared through level 1 and level 2 background screenings.

The amendment is submitted with the following revisions:

- The name change from Impact Broward, Inc. to South Florida Institute on Aging, Inc.
- 2. The change in SoFIA's address

3. The change to specify the annual allocation of funds

The FGP agreement was multi-year and did not include wording that would allow for payment to be rendered annually. The change to specify an annual allocation of funds was added to the Payment Process Section 2.10, as indicated below:

2.10 Payment Process: Foster Grandparents ("FGs") are paid \$2.65 per hour and/or \$0.40 per mile for transportation, as mandated by the Corporation for National and Community Service. Invoices are sent from SoFIA to the SBBC Public Information Office for review and approval. After the invoice is approved, it is sent to SBBC's Accounts payable for processing. Accounts Payable processes payment and issues a check to SoFIA in the amount of the invoice. The maximum amount of billing is \$170,537.00 annually.

## THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "SBBC"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

## SOUTH FLORIDA INSTITUTE ON AGING, INC. f/k/a IMPACT BROWARD, INC.

(hereinafter referred to as "SoFIA"), a Florida not for profit corporation, having its principal place of business at 2038 North Dixie Highway – Suite 201, Fort Lauderdale, Florida 33309.

WHEREAS, SBBC and Impact Broward, Inc. (hereinafter referred to as "Impact") entered into an Agreement dated June 13, 2017 (hereafter "Agreement"); and

WHEREAS, Impact Broward, Inc. has changed its name to South Florida Institute on Aging, Inc.

WHEREAS, the parties mutually desire to amend the Agreement to reflect the name change from Impact to SoFIA and to provide for annual funding for services rendered by Impact.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants contained herein and the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1.01 <u>Recitals</u>. The parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.

1.02 <u>Name Change</u>. The name IMPACT BROWARD, INC. ("Impact") shall be replaced with South Florida Institute on Aging, Inc. ("SoFIA") by interlineation, within the Agreement.

1.03 <u>Amended Provisions</u>. The parties hereby agree to amend Section 2.10 of the Agreement to provide as follows:

Page 1 of 4

2.10 <u>Payment Process</u>: Foster Grandparents ("FGs") are paid \$2.65 per hour and/or \$0.40 per mile for transportation, as mandated by the Corporation for National and Community Service. Invoices are sent from SoFIA to the SBBC Public Information Office for review and approval. After the invoice is approved, it is sent to SBBC's Accounts payable for processing. Accounts Payable processes payment and issues a check to SoFIA in the amount of the invoice. The maximum amount of billing is \$170,537.00 annually.

The parties hereby further agree to amend Section 2.12 of the Agreement to provide as follows:

2.12 <u>Notice</u>. When any of the parties desire to give notice to the other, such notice must be in writing, sent by U.S. Mail, postage prepaid, addressed to the other party for whom it is intended at the place last specified; the place for giving notice shall remain such until it is changed by written notice in compliance with the provisions of this section. For the present, the parties designate the following as the respective places for giving notice:

1.04 Order of Precedence among Agreement Documents. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- a) this First Amendment to Agreement; and then
- b) the Agreement.

1.05 <u>Other Provisions Remain in Force.</u> Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.

1.06 <u>Authority</u>. Each person signing this First Amendment to Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment to Agreement.
