The Venture Design Initiative was created to provide fee-supported premium services to charter schools, beyond the services required by Section 1002.33, Florida Statutes. This initiative is in its sixth year of operation and is strategically aligned under the Portfolio Services Division within the Innovative Programs Design/Support Department. Surveys continue to reveal the need for premium services to be provided to these schools as permitted by Section 1002.33(20) (b), Florida Statutes.

The attached Agreements delineate the negotiated terms as well as the structure and components that comprise the fee-supported services. The term of the Agreements are from October 16, 2018, to June 30, 2019.

The estimated positive revenue to the District for these 2018-2019 Premium Services Agreements will be based on the actual number of services requested and delivered to the pertinent charter schools.

These Agreements have been reviewed and approved as to form and legal content by the Office of the General Counsel.
