TITLE:
School Improvement Plans for Charter Schools 2018-2019 School Year

REQUESTED ACTION:
Approve School Improvement Plans (SIPs) for ten charter schools in alignment with State Board Rule 6A-1.099827, Florida Administrative Code, Charter School Corrective Action Plan and School Improvement Plans; Section 1008.33(3)(c), Florida Statutes; and Section 1002.33(9)(n), Florida Statutes.

SUMMARY EXPLANATION AND BACKGROUND:
Section 6A-1.0998271 (1)(a), Florida Administrative Code, states as follows: "[a] charter school that receives a grade of "D" or "F" pursuant to Section 1008.34(2), F.S., must develop and submit a school improvement plan to its sponsor." As stated in Section 6A- 1.099827(3), Florida Administrative Code, "[t]he director and a representative of the governing board shall appear before the sponsor at the publicly noticed meeting to present their SIP to the sponsor." The School Improvement Plan must include, at a minimum, the nine (9) elements outlined in Section 6A-1.099827(4), Florida Administrative Code.
