<b>REQUESTED ACTION:</b> Approve the Recreation License Agreement (RLA) between The School Board of Broward County, Florida (SBBC) and the City of Hollywood (City) for Hollywood Hills Elementary School.

<b>SUMMARY EXPLANATION AND BACKGROUND:</b> The City desires to enter into a new RLA for twenty-five (25) years with SBBC, which will allow the City to utilize the recreational facilities located to the east and west of Hollywood Hills Elementary School during non-school hours and for a rental payment of one dollar (\$1.00). In addition to the RLA, the City of Hollywood for years has had partnership agreements with SBBC, and currently has a Reciprocal Use Agreement (RUA) with SBBC. This Agreement will be executed by the City after School Board approval.
