Spending authority:

The Roll-off Unit Bid was built during a time when the District has regular construction and demolition (portables) projects going on throughout the District. This work has drastically slowed down over the past three (3) years. There are only seventeen (17) permanent locations in this bid, out of the 59 BCPS locations located in the geographical area serviced by this bid. The remaining forty-one (41) locations are on call. Our department has worked hard at reducing roll-off pulls at all the non-permanent locations. In addition, there are monies included in this contract to cover the costs of major storm and national type disasters. We have been fortunate the past three (3) years that the storms we have experienced have only resulted in minimal damage.

The spending authority has been reduced to a number that is more in line with the past three (3) year's actual spend, which is around \$115,000 per year; however, in case of any unforeseen events, including storms, additional spending authority will be requested, if needed.
