REQUESTED ACTION:

Approve the recommendation to award the above first amendment. Contract Term: July 1, 2018 through June 30, 2019, 1 Year; User Department: Broward Community Schools; Awarded Vendor(s): Cengage Learning, Inc.; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND:

This request is to approve the First Amendment, allowing The School Board of Broward County, Florida (SBBC), to renew the Agreement with Cengage Learning, Inc. for continuing education programs for adult students also known as Education To Go (ED2GO). Through a link on Broward Community School's portal, users have access to a plethora of self-paced and instructor-led courses for costs ranging from \$29.95 to \$475. All costs and fees for ED2GO courses are funded by the individual users, not SBBC.

This First Amendment to the Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.
