Inc.; The Sherwin Williams Company; Stein Paint Company; Small/Minority/Women Business Enterprise Vendor(s): None.

SUMMARY EXPLANATION AND BACKGROUND: The School Board of Broward County, Florida, received four (4) bids in response to ITB 18-022R. This Bid will be utilized mainly by the Material Logistics Stockroom PPO. This manufacturer list catalog bid enables PPO to purchase a wide array of painting products and supplies.
