TITLE:
State of Florida Statewide Voluntary Prekindergarten Provider Agreement between the Early Learning Coalition of Broward County, Florida, Inc. (ELC) and The School Board of Broward County, Florida (SBBC)

REQUESTED ACTION:
Approve the State of Florida Statewide Voluntary Prekindergarten Provider Agreement between the Early Learning Coalition of Broward County, Florida, Inc. (ELC) and The School Board of Broward County, Florida (SBBC) to implement the 2019-2020 Voluntary Prekindergarten (VPK) Education Program and to authorize the Superintendent of Schools or his designee to provide any electronic signatures necessary to execute the provider agreement.

SUMMARY EXPLANATION AND BACKGROUND:
SBBC agrees to implement the VPK Program for School Year 2019-2020 and Summer 2020. The term of this Agreement will be August 14, 2019 through August 13, 2020. SBBC will provide full-day (6 hours) and half-day (3 hours) VPK instructional models. Program models include: VPK/Extended Day (3 hours); VPK/Enrichment (6-hours that combines 3 hours of free VPK with optional 3 fee-based hours); VPK/Enrichment (6 hours free model that combines VPK funding with either Title I or Exceptional Student Learning Support funding) and a 300-hour Summer VPK program. This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.

FINANCIAL IMPACT:
