SUMMARY EXPLANATION AND BACKGROUND:
School Board Policy 1403 provides a procedure whereby schools can request waivers to School Board Policy and/or the BTU contract to remove barriers to school improvement. All waivers must be approved by 66 2/3 percent of faculty and be shared with the school community at public meetings. These waivers were reviewed and recommended by the District Review Panel, appropriate level Executive Principals Committee, and the Superintendent.
