First Amendment to Reciprocal Use Agreement with the City of Lauderhill

The City of Lauderhill had a Partnership Agreement with The School Board of Broward County, Florida (SBBC) for many years which was later converted to a Reciprocal Use Agreement (RUA). The RUA provides a mechanism for the City and the SBBC to use each other's facilities at minimal cost when the facilities are available.

In this First Amendment, the SBBC and City desire to amend Exhibits A and B of the RUA, to add the Wingate Oaks Center to Exhibit B as a site the City may utilize and to authorize the Superintendent or designee and the City Manager or designee, by mutual agreement, to add if necessary, additional future facilities to those currently identified in Exhibits A and B. The Principal has been consulted and is in agreement with the addition of Wingate Oaks Center to the RUA.

FIRST AMENDMENT TO RECIPROCAL USE AGREEMENT

> THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA (hereinafter referred to as "SBBC"),

a political subdivision of the State of Florida having its principal place of business at 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

THE CITY OF LAUDERHILL, FLORIDA (hereinafter referred to as "City") a municipal corporation of the State of Florida whose address is 5581 W. Oakland Park Boulevard, Lauderhill, Florida

WHEREAS, SBBC and City entered into a Reciprocal Use Agreement ("Agreement") which commenced on June 13, 2016; and

WHEREAS, Exhibits A and B of the Agreement identify both City-owned and SBBC-owned facilities subject to use by either Party; and

WHEREAS, SBBC and City currently desire to amend the Agreement to add one additional facility to those listed in Exhibit B; and

WHEREAS, SBBC and City desire to amend the Agreement to authorize the Superintendent of Schools (or designee) and the City Manager (or designee), by mutual agreement, to add if necessary, additional, future facilities to those currently identified in Exhibits A and B.

NOW, THEREFORE, in consideration of the mutual terms and conditions, promises, covenants, and payments, hereinafter set forth, SBBC and City hereby agree as follows:

1. Each and every WHEREAS clause set forth above is a true and correct recital and representation and is incorporated herein as if set forth in full.

2. Exhibit B to the Agreement shall be amended to include Wingate Oaks Center.

3. EXHIBIT A and EXHIBIT B to the Agreement shall be amended to <u>ADD</u> the following language:

(a) **Other City-owned facilities within the corporate limits of the City of Lauderhill may be added by mutual agreement of the Superintendent of Schools (or designee) and the City Manager (or designee) and without formal amendment of this Agreement.

(b) ** Other SBBC-owned facilities within the corporate limits of the City of Lauderhill, may be added by mutual agreement of the Superintendent of Schools (or designee) and the City Manager (or designee) and without formal amendment of this Agreement.

4. A copy of the First Amended **Exhibit A** and **B** is attached and incorporated as First Amended **Exhibit A** and **B**.

5. All other provisions of the Agreement shall remain in full force and effect.
