

EXECUTIVE SUMMARY

Below is an executive summary of the Amendment to the Agreement between The School Board of Broward County, Florida and College Board.

Project Description	The Amendment to the Chinese Guest Teacher Agreement between College Board and The School Board of Broward County, Florida, will enable the current guest teacher from the People's Republic of China to continue to teach Chinese language and culture at Millennium 6-12 Collegiate Academy subject to the terms and conditions of the contract. College Board will provide \$13,000 toward the teacher's salary. The Chinese Guest Teacher Agreement is effective through June 3, 2020.

SECOND AMENDMENT TO AGREEMENT

This Second Amendment to Agreement (“*Amendment*”) is entered into as of _____ 2019 by and between School Board of Broward County, Florida (“*SBBC*”) and the College Board (“*College Board*” and together with SBBC, collectively referred to herein as the “Parties” and individually, as a “Party”).

WHEREAS, the Parties are parties to that certain Agreement made and entered into as of 6th day of June, 2017 (the “*Agreement*”) which provides the terms and conditions of the Chinese Guest Teacher program pursuant to which SBBC hosts guest teachers from the People’s Republic of China to teach Chinese language and culture om Broward County Public Schools; and

WHEREAS, SBBC has requested, and College Board has agreed, to extend SBBC’s participation in the Program for another one year term and to amend the Agreement as more fully described in this Amendment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, and intending to be legally bound, the Parties agree as follows:

1.0 The following items ae

1. Amendments.

- (a) Section 3 of the Agreement is hereby amended by replacing the term “2018” with “2020”.
- (b) Section 4 of the Agreement is hereby amended by amending the definitions of “Start Date” to August 7, 2019 and “End Date” to June 3, 2020.
- (c) Section 4(E) of the Agreement is hereby amended by replacing the term “2018” with “2020”.
- (d) Section 4(N) of the Agreement is hereby amended by replacing the following phrases: (i) “2017-2018 school year” with “2019 – 2020 school year”; (ii) “May 10, 2017” with “May 17, 2019”; and (iii) “June 2, 2017” with “June 6, 2019”.
- (e) Section 5(B) of the Agreement is hereby amended by replacing the term “2018” with “2020”.
- (f) Section 7(A) of the Agreement is hereby amended by amending the nonrefundable admirative fees by replacing the list of fees in its entirety as follows:

and (ii) replacing the phrase “June 7, 2018” in the second bullet point with “June 3, 2020”.

2.0 Order of Precedence among Agreement Documents. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- a) this Second Amendment to Agreement; and
- b) the First Amendment to Agreement; and
- c) the Agreement.


