## TITLE:

Direct Negotiation Agreement - FY20-094 - Dual Enrollment Articulation for University of Florida (UF)

#### **REQUESTED ACTION:**

Approve the recommendation for the above Agreement. Contract Term: August 1, 2019 through July 31, 2021, 2 Years; User Department: Secondary Learning; Award Amount: \$424,000; Awarded Vendor(s): University of Florida Board of Trustees; Small/Minority/Women Business Enterprise Vendor(s): None.

### SUMMARY EXPLANATION AND BACKGROUND:

As encouraged by Florida Statute (F.S. 1007.235), The University of Florida Board of Trustees and The School Board of Broward County, Florida, can enter into a Dual Enrollment Articulation Agreement to offer dual enrollment courses to all eligible secondary school students. This Agreement will provide an opportunity for students to complete university-level courses necessary to complete a four (4) year degree, while also completing a high school diploma. This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.

This Agreement will be executed after School Board approval.
