## SUMMARY EXPLANATION AND BACKGROUND:

As encouraged by Florida Statute (F.S. 1007.235), Florida International University and The School Board of Broward County, Florida, can enter into a Dual Enrollment Articulation Agreement to offer dual enrollment courses to all eligible high school students. This Agreement will provide an opportunity for students to complete university-level courses necessary to complete a four (4) year degree, while also completing a high school diploma.
