Revisions to Policy 6000.1: Student Progression Plan

REQUESTED ACTION:
Adopt revisions to Policy 6000.1: Student Progression Plan, at this Final Reading.

SUMMARY EXPLANATION AND BACKGROUND:
The District Policy 6000.1 Committee convened throughout the school year to address issues and formulate proposed changes for the 2019-20 school year. A broad representation of district and school-based staff, along with parents and students participated in the committee. The Chart of Substantive Changes addresses all revisions recommended at this time. One additional "State Change" was made due to the enactment of SB 850 between Reading 1 and Reading 2. These revisions were discussed at the May 14, 2019 School Board Workshop and the June 18, 2019 Public Rule Development Meeting. This policy was advertised on May 6, 2019 for the First Reading and June 16, 2019 for the Second Reading.
