SUMMARY EXPLANATION AND BACKGROUND:
 The School Board of Broward County, Florida, received twenty-six (26) bids in response to ITB 17-009V - School and Department Furniture. This request is to renew to twenty (20) vendors that will supply classroom and office furniture to the District. This Bid includes a single-fixed percentage discount from manufacturer's catalog/list price and also includes furniture with firm-fixed pricing that is consistently purchased throughout the District. The financial impact amount represents an estimated contract value; however, the amount authorized will not exceed the contract award amount.
