SUMMARY EXPLANATION AND BACKGROUND: In 2002, the Florida Legislature approved Statute 318.1215 the Don Slosberg Driver Education Safety Act, which provides additional funding for the driver education programs in public and non-public schools. The legislation provides funding for the direct educational expenses of the driver education program. The funding, from this statute, comes from fees paid as part of traffic tickets. This Agreement has a start date of October 1, 2018, in order to provide funding for this current fiscal year. This provider agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel. The Board of County Commissioners of Broward County will sign this Agreement following School Board approval of this Agreement.
