REQUESTED ACTION:
 Approve the first renewal and additional spending authority for the above Invitation to Bid (ITB). Contract Term: August 1, 2016 through July 31, 2020, 4 Years; User Department: Physical Plant Operations (PPO); Additional Requested Amount: \$420,000. New Award Amount: \$2,420,000; Awarded Vendor(s): Xpert Elevator Services, Inc.; Small/Minority/Women Business Enterprise Vendors: None.

SUMMARY EXPLANATION AND BACKGROUND:
 The School Board of Broward County, Florida, received four (4) bids in response to Bid 16-061C - Maintenance and Repair of Elevators and Wheelchair Lifts. This Bid will be utilized by PPO as part of its preventive/routine maintenance program to provide maintenance and repair services for elevators and wheelchair lifts throughout the District.

 The estimated financial impact to the District will be \$420,000. The contract award amount was for \$2,000,000. The request is to increase the spending authority by \$420,000, bringing the new contract value to \$2,420,000. The funding source will come from PPO's operating budget. The financial impact amount represents an estimated contract value; however, the amount authorized will not exceed the contract award amount.
