



**Pre-Paid Customer(s)** I (we) agree to pay the City of Plantation Finance Department, in advance, the above requested hours at the prevailing hourly rate per person and an additional special fee per hour for every required supervisor. I (we) understand and agree to pay for a minimum of three hours service per person and/or required supervisor.

**Reoccurring Customer(s)** I (we) agree to pay the City of Plantation Finance Department, UPON RECEIPT OF OFFICIAL BILL, the above-requested hours at the prevailing hourly rate per person and an additional special fee per hour for every required supervisor. I (we) understand that we have 30 days from date of invoice to pay in full, or there will be a 1% finance charge for every month that payment is late.

I (we) further understand personnel assigned are working as public Police Officers or Community Service Aides, subject to all duties and responsibilities of their position. Said personnel shall be subject to any departmental call for assistance or back-up that may arise during assignment as herein requested, which may cause the assigned police officer or other personnel to leave the location, and he/she is subject to all rules and regulations, policies and procedures of the City of Plantation and the Police Department. The City further assures the applicant that only certified Police Officers, Police Reserve Officers, or Community Service Aides of the City of Plantation will be assigned to this duty.

I (we) understand the City assumes no special duty to me (us) as to police protection or traffic control by entering into this contract. This means that the City is providing the same service to you which the City provides to the population in general. The City is not representing or guaranteeing that crime will be prevented or reduced at your location by this special assignment. Further, the City is not representing or guaranteeing that any traffic control contracted for herein will prevent or reduce traffic stoppages or traffic accidents.

In the event the Police Department cannot provide the requested personnel at the date and time specified herein for any reason, the Department shall attempt to notify the listed contact person as soon as it determines that it is unable to place the requested number of personnel at the location specified. Otherwise, this contract is terminable at will by either party upon 30 hours notice, in writing or by telephone, to the contact person set forth below.

In the event the Police Department cannot place the requested number of personnel at the location specified, the parties stipulate and agree that the sole remedy of the requesting party shall be refund of any deposit or fee paid to the City. The Police Department shall not be liable for any other damages in the event of breach of this agreement.

I (we) understand any change in schedule or cancellation must be communicated to the Department and scheduled employee not less than 30 hours prior to start of the contract time. Failure to notify will result in full payment of the contract amount.


