EXECUTIVE SUMMARY

Recommendation of \$500,000 or Greater FY20-097 - Purchase/Repair of New/Used/Re-conditioned Golf Cart

Introduction:

Responsible: Procurement & Warehousing Services

This request is to approve the recommendation to award Invitation to Bid (ITB) FY20-097-Purchase/Repair of New/Used/Re-conditioned Golf Cart for a period of three (3) years from October 2, 2019 through September 30, 2022, with a renewal option for two (2) additional one (1) year periods. The spending authority for this ITB is \$1,140,000.

Goods/Services Description

Responsible: Physical Plant Operation (PPO)

ITB FY20-097 will be utilized throughout the District's schools, centers, and departments. This ITB provides for the purchase of new, used, and reconditioned golf carts. The ITB also includes, repairs, including but not limited to: the replacement of 6V, 8V and/or 12V batteries, cables, keys, key switches, headlights, and tires. With regards to repairs, the awardees are required to perform an assessment of the vehicles and for site repairs, or pick-up service for repairs at the awardees' local repair shop. This ITB also includes the option for a daily rental rate of golf carts. This will allow schools to replace any vehicle that might be down for repairs or the option to acquire an additional vehicle for special events without the need to purchase additional vehicles.

Procurement Method Responsible: PWS

This solicitation for this ITB ran from June 3, 2019 through July 2, 2019. There were ninety-three (93) vendors notified, and ten vendors (10) downloaded the ITB. Procurement & Warehousing Services received five (5) bids. The recommendation for the award was based on the lowest price for Group 1 and Group 3. For Group 2, the recommendation for the award was based on the highest fixed percentage discount. The vendors recommended for the award are Advantage Golf Cars, Inc., Jeffrey Allen, Inc., Nasrep Inc. d/b/a Broward Electric Car & Equipment, Southern Golf Cars and Golf Car& Utility Vehicle Distributors d/b/a Tropicars.

The Affirmation Procurement Initiative recommended by the Supplier Diversity and Outreach Program for this Bid was Voluntary S/M/WBE distributorship development program, in which The School Board of Broward County, Florida, encourages manufacturers to establish authorized dealerships or distributorships with S/M/WBE suppliers of their products on a non-discriminatory basis.

Financial Impact Responsible: PWS

Per Purchase Policy 3320, the District purchased golf carts by obtaining the required quotation, if the purchase was less than \$5,000, or three (3) competitive written quotations for purchases between \$5,000 to \$50,000. There has been a significant increase in the purchase of golf carts due to the District's improved security measures and the school choice funds from the SMART program. This ITB provides the District with firm pricing for golf cart purchases, establishes standards for repair or maintenance service, and establishes a standard for golf cart warranties.

Documents/records in any form shall be open to the District or State's representative and may include but are not limited to all correspondence, ordering, payment, inspection, and receiving records, contracts or subcontracts that directly or indirectly pertain to the transactions between the District and the Awardee(s).
- 56. <u>ORIGINAL DOCUMENT FORMAT:</u> Only the terms and conditions of this solicitation as they were released by SBBC, or amended via Addendum, are valid. Any modification to any term or condition by a Bidder is not binding unless it is expressly agreed to, in writing, by SBBC.

Each such party agrees, for itself, its officers, employees, agents, representatives, contractors or subcontractors, to fully indemnify and hold harmless SBBC and its officers and employees for any violation of this section, including, without limitation, defending SBBC and its officers and employees against any complaint, administrative or judicial proceeding, payment of any penalty imposed upon SBBC, or payment of any and all costs, damages, judgments or losses incurred by or imposed upon SBBC arising out of a breach of this covenant by the party, or an officer, employee, agent, representative, contractor, or sub-contractor of the party shall either intentionally or negligently violate the provisions of this section or of Sections 1002.22 and/or 1002.221, Florida Statutes.

Awardee agrees that it may create, receive from or on behalf of SBBC, or have access to, records or record systems that are subject to FERPA and/or HIPAA (collectively, the "Confidential Records"). Awardee represents, warrants, and agrees that it shalt: (1) hold the Confidential Records in strict confidence and shall not use or disclose the Confidential Records except as (a) permitted or required by this Agreement, (b) required by law, or (c) otherwise authorized by the SBBC in writing; (2) safeguard the Confidential Records according to commercially reasonable administrative, physical and technical standards as required by law, and (3) continually monitor its operations and take any and all action necessary to assure that the Confidential Records are safeguarded in accordance with the terms of this Agreement. At the request of the SBBC, Awardee agrees to provide SBBC with a written summary of the procedures Awardee uses to safeguard the Confidential Records. A breach of these confidentiality requirements shall constitute grounds for the SBBC to terminate any Agreement with Awardee.

64. PROPRIETARY INFORMATION: Pursuant to Chapter 119, Florida Statutes, bids received as a result of this ITB shall not become public record until thirty (30) days after the date of opening or until posting of the recommendation for award, whichever occurs first. Thereafter, all bid documents or other materials submitted by all Bidders in response to this ITB shall be open for inspection by any person and in accordance with Chapter 119, Florida Statutes. To the extent a Bidder asserts any portion of its bid is confidential and exempt, long with specific citations of the Florida Statutes establishing the confidentiality or exemption. Failure to identify the portions of the bid claimed to be exempt or the specific statutory authority establishing the exemption shall be deemed a waiver by the Bidder that any unidentified portion of the bid is confidential or exempt from disclosure under Chapter 119, Florida Statutes.

Should a public records request for bid documents or other materials submitted by a Bidder be submitted, SBBC shall notify the contact person identified in the bid of the request in writing. The notice provided shall indicate that requested materials shall be produced unless, within ten (10) calendar days of the date of the written notification, the Awardee initiated an action in a court of competent jurisdiction to obtain an injunction or protective order prohibiting the release of the requested materials. Awardee shall name the party requesting the materials as a defendant and shall not name SBBC as a party to the action. Awardee agrees to hold SBBC harmless from any award to a plaintiff for damages, costs or attorney's fees based on nondisclosure of information asserted to be confidential and exempt. Failure to timely initiate the action shall be deemed a waiver by the Awardee that the requested information is confidential and exempt. Awardee agrees to waive any cause of action it may have against SBBC for the release of materials pursuant to a public records request except those based on the intentional or grossly negligent conduct of any employee of SBBC. Submission by a Bidder in response to this ITB shall be deemed as Bidder's consent to the foregoing conditions.

If necessary, the appropriate Administrator or his/her designee may request a loaner vehicle at the rate indicated on Bid Summary Sheet. If completion of repairs takes longer than original estimated. A loaner vehicle shall be provided by Vendor at no additional cost to the School District. Any subsequent problems found as the result of the primary repair operation shall also require written estimates and District approval, as above, before undertaking the additional repairs.

MINIMUM LIMITS OF INSURANCE REQUIREMENTS

Insurance Requirements. Vendor shall comply with the following insurance requirements throughout the term of this Agreement.
