Continuation of Summary Explanation and Background:

Franklin Academy Foundation, Inc., on behalf of Franklin Academy Sunrise – 5010, desires to amend its charter school renewal agreement to change the Florida not-for-profit corporation name from Florida Charter Foundation, Inc., to Franklin Academy Foundation, Inc., for the 2019 – 2020 school year and subsequent years.

Pursuant to Section 1002.33, Florida Statutes, the terms and conditions for the operation of a charter school shall be set forth by the charter school and The School Board of Broward County, Florida, in a written contractual agreement. This agreement shall constitute a school's charter. A First Amendment to the Charter School Renewal Agreement is submitted for School Board approval to address the change requested by the charter school. The term of the Charter School Renewal Agreement will remain the same as that of the original and will expire on June 30, 2031.

The charter school is located at 4500 NW 103rd Avenue, Sunrise, Florida 33351, which is in District 6.

The governing board members of Franklin Academy Foundation, Inc., reside in Broward County, Florida.

On June 7, 2011, The School Board of Broward County, Florida, approved an initial charter agreement with Franklin Academy Foundation, Inc., for a term of five years. On May 5, 2015, the school amended its Agreement to change its location. On June 15, 2016, The School Board of Broward County, Florida, approved a renewal of the agreement with Franklin Academy Foundation, Inc., on behalf of Franklin Academy Sunrise – 5010. This contract is effective for fifteen (15) years and ends on June 30, 2031.

Franklin Academy Foundation, Inc., desires to amend its charter school renewal agreement by changing the name of the Florida not-for profit corporation from Florida Charter Foundation, Inc, to Franklin Academy Foundation, Inc. for the 2019-2020 school year and subsequent years.

The term of the charter shall remain the same, covering fifteen years commencing on July 1, 2016, and ending June 30, 2031.

Franklin Academy Sunrise – 5010, is located at 4500 NW 103rd Avenue, Sunrise, Florida 33351, which is in District 6.

FIRST AMENDMENT TO THE CHARTER SCHOOL RENEWAL AGREEMENT

This First Amendment to the Charter School Renewal Agreement is made and entered into as of this 6th day of November 2019, by and between:

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA,
a body corporate operating and existing under the laws of the State of Florida
[hereinafter referred to as "Sponsor"],
and having its principal place of business located at
600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

FRANKLIN ACADEMY FOUNDATION, INC
f/k/a FLORIDA CHARTER FOUNDATION, INC.
a Florida not-for-profit organization
[hereinafter referred to alternatively as "Franklin Academy Sunrise f/k/a Franklin Academy B"
or "School"],
and having its principal place of business located at
4500 NW 103rd Avenue
Sunrise, FL 33351

WHEREAS, the parties entered into a Charter School Renewal Agreement ("Agreement") on or about June 15, 2016, for a 15-year period expiring June 30, 2031, which incorporated by reference the Charter Renewal Program Review wherein the School was authorized to operate a charter school (grades K-8); and

WHEREAS, Section 2.B.4 of the Agreement permits the amendment of the Agreement during its term through mutual agreement of the parties, provided such modifications are agreed to in writing and executed by both parties; and

WHEREAS, Florida Charter Foundation, Inc., desires to amend the Agreement to reflect a change in its name; and

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and terms herein set forth, the parties agree as follows:

1.01 Recitals: The foregoing recitals are true and correct and are incorporated within this Amendment by reference.

1.02 Change of Name: School's name shall be changed throughout the Agreement to Franklin Academy Foundation, Inc.

1.03 Order of Precedence Among Agreement Documents: In the event of a conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- (a) This First Amendment to the Charter School Renewal Agreement;
then
- (b) The Charter School Renewal Agreement; then
- (c) The Charter Application.

1.04 Other Provisions, as Amended, Remain in Force: Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.

1.05 Authority: Each person signing the First Amendment to the Charter School Renewal Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to the Charter School Renewal Agreement.
