The School Board of Broward County, Florida, met in special session at 1:12 p.m. in the Board Room of the Kathleen C. Myrick, Esq.

<u>Call to Order</u> Presiding, the Superintendent called this meeting to order and was followed by the Pledge of Allegiance to the Flag of the United States of America.

Close Agenda Upon motion by Mrs. Good, seconded by Dr. Osgood and carried, the Agenda was approved and declared closed. (9-0 vote)

# ORGANIZATION OF THE BOARD

### Nomination of Chair

As Acting Chair, the Superintendent asked for nominations for Chair of The School Board of Broward County, Florida.

Mrs. Heather Brinkworth was nominated for the office of Chair by Mrs. Rupert, seconded by Dr. Osgood.

## Close Nominations for Chair

Motion was made by Dr. Osgood, seconded by Ms. Korn and carried, to close the nominations for Chair. (9-0 vote)

#### <u>Vote</u>

Following a unanimous vote, Mrs. Brinkworth was elected Chair of The School Board of Broward County, Florida for the ensuing year. (9-0 vote)

## Statement by Superintendent

Mr. Runcie thanked Mrs. Rupert for her services in the role as Chair for 2017-2018 and presented her with a crystal plaque and bouquet of flowers. Mrs. Brinkworth was also presented with a bouquet of flowers as she began her term as Chair for 2018-2019.

Mr. Runcie then turned the gavel over to Mrs. Brinkworth who assumed the role of Chair and conducted the remainder of this meeting.

Mrs. Brinkworth thanked her colleagues for electing her to serve as Chair for the next year. She said it was a great honor and privilege to serve, not only the community, but with her colleagues as well. She extended a welcome to the new Board Member, Lori Alhadeff. #### Vote

Statement by Vice Chair

Ms. Korn thanked her colleagues for the opportunity and stated she looked forward to working with the Chair and fulfilling any obligations that the Chair would be unable to do. She said she was thrilled to work with her colleagues in moving this District forward. She stated it had been very challenging this past year and hoped the coming year would be one of celebration. She also thanked Mrs. Rupert for serving as Chair and the role she played over the past year was one that would have been challenging for all of them and she played a pivotal role in being able to bring leadership to the Board and District during this difficult time. She appreciated her leadership and for keeping everyone on track to stay focused.

Statements by Board Members

The Chair opened the floor to her colleagues to share their gratitude to Mrs. Rupert for serving the past year as Chair.

Mrs. Alhadeff congratulated the 2018 Marjory Stoneman Douglas (MSD) Eagle Regiment on winning back-to-back FMBC Class 5A State Marching Band Championships.

Mrs. Good thanked the outgoing Chair, especially the multitude of times for public speaking, which was an important part this past year. She also, congratulated the incoming Chair who she believed was a class act and would be an amazing Chair, as well as to the Vice Chair.

Mrs. Bartleman thanked Mrs. Rupert for serving during a tough year, who did a great job weathering a lot of storms with grace and dignity every step of the way. She stated she looked forward to the new Chair and Vice Chair serving in their leadership role, as well as the Board being a team. She believed every Board Member would rise to the challenge, and put children, education, and safety first. She was excited to serve with each of her colleagues and said it would be a great year with the Board making a difference in the changes that had to be made. She also welcomed Mrs. Alhadeff to the Board.

The audience congratulated the Chair and Vice Chair on their elections.

# A-1. Resolution 19-100, Designation of Election of Chair, Vice Chair, Meeting Dates, Names and Addresses of Members and Secretary (Adopted)

Motion was made by Ms. Korn, seconded by Mrs. Rupert and carried, to adopt Resolution No. 19-100, designating the election of Chair, Vice Chair, meeting dates, names, and addresses of Members and Secretary. (9-0 vote)

The adoption of this resolution was required by Florida Statutes 1001.371, Organization of Board, and Florida Statutes 1001.362, Officers chosen at general election.

There was no financial impact to the District.

The Chair received audience input on this item.

Ms. Murray referred to the 2018-2019 Schedule and asked if the Board would receive a break this year.

Mr. Runcie responded by saying the Board would have a break from June 11, 2019 through July 23, 2019.

Mr. Moquin added that this mirrored the current year's schedule. The Board always had two meetings in June in order to close out the fiscal year. He said the Board would have three (3) weeks off at the beginning of July and would be required to come back for the July 23, 2019 Regular School Board Meeting to adopt the millage by statute for the Budget.

Mrs. Good inquired regarding the meeting being held on a Wednesday in September because of a holiday on Monday.

Mr. Moquin responded affirmatively. He stated that was not the same for Workshops but in order to provide opportunity for the Board to get last minute responses for inquiries, typically the Board meeting would be held on a Wednesday.

# A-2. Resolution 19-101, Authorization of Facsimile Signatures

The adoption of this resolution was in accordance with Florida Statute 116.34, Facsimile Signatures and said resolution must be filed with the Secretary of State. A facsimile signature has the same legal effect as a manual signature.

# A-3. Resolution 19-102, Authorization of Signatures and Use of Manual, Stamped or Facsimiles (Adopted)

Motion was made by Ms. Korn, seconded by Mrs. Rupert, and carried, to adopt Resolution No. 19-102, Authorization of Signatures and Use of Manual, Stamped or Facsimiles. (9-0 vote)

The adoption of this resolution was required by banks used as depositories for the funds of The School Board of Broward County, Florida.
