### FIRST AMENDMENT TO CONSTRUCTION AGREEMENT

**THIS FIRST AMENDMENT TO AGREEMENT** is made and entered into as of this 4th day of February, 2020, by and between

## THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "Owner"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

# CB CONSTRUCTORS, INC.

(hereinafter referred to as "Contractor"), having its principal place of business at 2251 Blount Road Pompano Beach, FL 33069

WHEREAS, the Owner and Contractor entered into a Construction Agreement dated October 15, 2019 (hereafter "Agreement") for SMART Program Renovations at Sea Castle Elementary School Project No. P.001632 (the "Project"); and

**WHEREAS**, the approved Agreement contained a scrivener's error incorrectly indicating a construction duration for the Project of 365 calendar days; and

WHEREAS, Owner and Contractor acknowledge and agree that the correct construction duration is 330 calendar days; and

**WHEREAS**, Owner and Contractor acknowledge and agree that the Agreement is in full force and effect as revised by this First Amendment.

**NOW THEREFORE**, in exchange for the mutual covenants and promises set forth herein and other good and valuable consideration, the parties agree as follows:

1. <u>Recitals.</u> The recitals contained herein are true and correct and are incorporated herein by reference.

2. <u>Amended Provision</u>. Article 4.03.01 is hereby amended to indicate a construction duration of 330 calendar days.

3. <u>Other Provisions Remain in Force.</u> Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.

4. <u>Order of Precedence among Agreement Documents</u>. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

a) this First Amendment to Agreement; then

b) the Agreement.

5. <u>Authority</u>: Each person signing this First Amendment on behalf of either party warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing it to bind and obligate such party with respect to all provisions contained in this First Amendment.


