Change Order Items:

Item #1 – (COI #1) Remote Command Center: Additional labor and material are required for the new remote command center with associated wiring to be installed in the cafeteria, as per direction by the District's Chief Fire Official. (Owner's Request - \$17,714; Add 0 days)

Item #2 – (COI #2) Positive Alarm Sequence: Additional labor, material, and programming are required for the fire alarm scope of work in order to program the positive alarm sequence as per direction by the District's Chief Fire Official. (Owner's Request - \$14,647; Add 0 days)

Item #3 – (COI #3) Annunciate Buildings Separately: Additional labor, material, and programming are required for the fire alarm scope of work in order to allow buildings to annunciate separately, as per direction by the District's Chief Fire Official. (Owner's Request -\$4,728; Add 0 days)

Item #4 – (COI #4) Fire Alarm Devices in Restroom 111 and 112:

Additional labor and material are required in order to install Fire Alarm Devices amid the change in Fire Alarm Specifications. Devices were not required for voice evacuation systems. Due to the specification change, the devices were required to be removed and reinstalled to obtain occupancy for school opening. (Owner's Request - \$5,559; Add 0 days)

Item #5 – (COI #5) Credit for Fire Alarm Labor Hours: Credit from Fire Alarm Contractor for the Labor Hours related to Fire Alarm Scope. (Owner's Request - Credit for \$1,967; Add 0 days)

Action Plan:

The project is currently pending sign off for fire alarm in order to closeout. This change order has been reviewed for entitlement and cost by CBRE | Heery, Inc. and Atkins with a recommendation for approval from CORP.
