**REQUESTED ACTION:**  
Approve the 2020 High School Graduation Use License Agreement with Nova Southeastern University for nineteen graduation ceremonies at the Rick Case Arena at the Don Taft University Center.

**SUMMARY EXPLANATION AND BACKGROUND:**  
Nova Southeastern University will be the 2020 graduation host site for approximately nineteen public high schools. These graduation ceremonies will be conducted May 27 through June 2, 2020.
