EXECUTIVE SUMMARY

Recommendation to Approve Second Amendment and Renewal 58-130E – Virtual Interactive Training Agent (VITA) Program

Introduction

Responsible: Procurement & Warehousing Services (PWS)

This request is to approve the Second Amendment and Renewal of the Agreement between The Dan Marino Foundation, Inc. and The School Board of Broward County, Florida (SBBC). The agreement was approved by the School Board at the School Board Operational Meeting (SBOM) on June 12, 2018, under item EE-7 for one (1) year, starting June 13, 2018 through June 13, 2019. The First Amendment and Renewal was approved at the SBOM as EE-22 on June 11, 2019. This renewal will extend the expiry date to June 13, 2021.

There is no spending authority being requested as this is funded by the Dan Marino Foundation.

Goods/Services Description

Responsible: Exceptional Student Learning Support (ESLS)

Broward County Public Schools is required under federal legislation to educate and provide Transition Services for all identified transitioning students with disabilities. "Transition Services" is a term used in the Individuals with Disabilities Education Act (IDEA) that defines a coordinated set of activities that may address, among others, the assessment, planning process, educational, and community experiences for youth with disabilities as they turn age fourteen (14). The intent of transition services is to create opportunities for youth with disabilities that lead to positive adult outcomes. SBBC seeks to enter into this Agreement with the Dan Marino Foundation to increase students' opportunity to obtain gainful employment through utilizing their Virtual Interactive Training Agent system to practice and significantly improve interview skills.

Each school received a licensed station (initial software download) and a sub-station (secondary software download). There are twenty (20) schools utilizing two (2) ViTA softwares each.

The following schools will participate in this grant award:

High: Marjory Stoneman Douglas, Monarch, Dave Thomas, Coral Glades, Deerfield Beach, Sheridan-Career Placement and Access, Atlantic Technical-Career Placement and Access, Whispering Pines, Hallandale, Cypress Bay, Blanche Ely, Fort Lauderdale, Boyd Anderson, Coconut Creek, Coral Springs, Miramar, Everglades, J.P Taravella, Dillard and Nova.

Procurement Method Responsible: PWS

Pursuant to Purchasing Policy 3320, Section II, N, a contract for commodities or contractual services may be awarded, without competitive solicitations, if state or federal law, a grant or a state or federal agency contract prescribes with whom The School Board must contract or if the rate of payment is established during the appropriations process.

SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT TO AGREEMENT is made and entered into as of this day of _______, 2020, by and between

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "SBBC"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

THE DAN MARINO FOUNDATION, INC.

(Hereinafter referred to as "VENDOR"), a Florida not-for-profit whose principal place of business is 400 North Andrews Avenue, Fort Lauderdale, FL 33301

WHEREAS, SBBC and VENDOR entered into an Agreement dated June 12, 2018, (hereafter "Agreement") that commenced on June 12, 2018 and concluded on June 13, 2019; and

WHEREAS, the parties amended the Agreement on June 11, 2019 through a First Amendment to Agreement that will expire on June 13, 2020; and

WHEREAS, the SBBC is in need of non-exclusive rights to the Licensed Program for Interview Training Use as well as certain support services and has selected the VENDOR to provide such products and services; and

WHEREAS, VENDOR is willing to grant such license and provide certain services related thereto, as set forth herein to the SBBC; and

WHEREAS, the parties mutually desire to amend certain provisions of the Agreement through this Second Amendment to Agreement (hereafter "Amendment").

- **NOW, THEREFORE**, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:
- 1.01 <u>Recitals</u>. The Parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.
- 1.02 <u>Term of Agreement</u>. Pursuant to Article 2.0 of the Agreement, the term of the Agreement is hereby extended from June 14, 2020 through June 13, 2021 unless terminated earlier pursuant to Article 3.06 of the Agreement.

- 1.03 Order of Precedence among Agreement Documents. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:
 - a) This Second Amendment to Agreement; then
 - b) The First Amendment to Agreement; then
 - c) The Agreement; then
 - d) Attachment A and B
- 1.04 Other Provisions Remain in Force. Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.
- 1.05 <u>Authority</u>. Each person signing this Second Amendment to Agreement on behalf of either party individually warrants that he or she has full legal power to execute this Second Amendment to Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Second Amendment to Agreement.
