





ON OCTOBER 2, 2018, THE SCHOOL BOARD APPROVED THE RECOMMENDATION FROM THE SUPERINTENDENT OF SCHOOLS TO TERMINATE MR. CRAIG DUDLEY, A TEACHER. THE LEGAL BASIS FOR HIS TERMINATION WAS JUST CAUSE, MISCONDUCT IN OFFICE, INCOMPETENCY, GROSS INSUBORDINATION, WILLFUL NEGLECT OF DUTY, AND VIOLATION OF SCHOOL BOARD POLICIES 2400 - DRUG FREE WORKPLACE; 4008 - RESPONSIBILITIES AND DUTIES; AND 4.9 - CORRECTIVE ACTION.

MR. DUDLEY CHALLENGED THE SCHOOL BOARD'S ACTION AND REQUESTED AN ADMINISTRATIVE HEARING BEFORE THE STATE OF FLORIDA DIVISION OF ADMINISTRATIVE HEARINGS. FOLLOWING THE ADMINISTRATIVE HEARING, THE ADMINISTRATIVE LAW JUDGE ISSUED A RECOMMENDED ORDER, RECOMMENDING THAT THE SCHOOL BOARD ENTER A FINAL ORDER (1) SUSPENDING RESPONDENT FROM HIS TEACHING POSITION WITHOUT PAY COMMENCING ON THE DATE ON WHICH HE WAS REASSIGNED FROM THE CLASSROOM; (2) REINSTATING RESPONDENT TO HIS TEACHING POSITION; AND (3) REQUIRING RESPONDENT TO SUBMIT TO RANDOM DRUG AND ALCOHOL TESTING, AT HIS PERSONAL EXPENSE, AS A CONDITION OF HIS CONTINUED EMPLOYMENT.

ON OCTOBER 22, 2019, A SPECIAL SCHOOL BOARD MEETING WAS HELD TO CONSIDER THE RECOMMENDED ORDER, RENDERED ON JULY 17, 2019, BY THE ADMINISTRATIVE LAW JUDGE. THE SCHOOL BOARD REJECTED THE SUPERINTENDENT'S RECOMMENDATION TO TERMINATE MR. DUDLEY AND ORDERED THAT MR. DUDLEY BE SUSPENDED WITHOUT PAY FOR THE PERIOD COMMENCING OCTOBER 2, 2018, AND ENDING ON OCTOBER 22, 2019 AT WHICH TIME HE WOULD RETURN TO EMPLOYMENT.

ON MARCH 4, 2020, THE FLORIDA DEPARTMENT OF EDUCATION OFFICE OF PROFESSIONAL PRACTICES COMMISSION SUSPENDED MR. DUDLEY'S EDUCATOR'S CERTIFICATE. THEREFORE, MR. DUDLEY IS NOT QUALIFIED TO BE A TEACHER AND IS BEING RECOMMENDED FOR TERMINATION.
