## **EXECUTIVE SUMMARY**

## Recommendation to Approve First Amendment and Renewal FY20-072 – Global Citizenship e-Classroom for Middle Students Around the World

## Introduction

## Responsible: Procurement & Warehousing Services (PWS)

This request is to approve the First Amendment and Renewal of the Agreement between Global Cities, Inc. and The School Board of Broward County, Florida (SBBC), that facilitates the program called Global Scholars which connects participating middle school students to other national and international students using internet-based educational activities, project-based learning, and other instructional strategies to develop students global citizenship while enhancing critical Twenty-First Century skills.

The agreement was approved by the School Board at the Regular School Board Meeting on June 25, 2019, under Item E-3 for one (1) year starting July 1, 2019 through June 30, 2020, with a renewal option for two (2) additional one (1) year periods.

The purpose of the amendment is to renew for an additional year, extending the contract through June 30, 2021.

There is no financial impact to the District.

## Goods/Services Description Responsible: Innovative Learning

Global Scholars delivers a blended learning delivery model, providing access to interactive, multimedia, online classroom, and original curriculum materials that enable students to learn and communicate about important global issues that have a local impact.

Successful implementation included subject content mastery, effective English language communication, and technology proficiency. In Broward, this program is offered as an elective, within a specific content area or as an afterschool club. In preparation for their facilitation role, teachers receive professional development through distance learning, support from the District, and the program provider as well as opportunities to connect to a worldwide network of educators.

## SBBC PARTICIPATION AGREEMENT for GLOBAL CITIES INC. PROGRAM

THIS AGREEMENT, dated as of the <u>25th</u> day of <u>(cente)</u>, 2019 ("Agreement"), between The School Board of Broward County, Florida (the "SBBC"), having its principal office at 600 Southeast 3rd Avenue, Fort Lauderdale, FL 33301 and **GLOBAL CITIES INC.**, a Program of Bloomberg Philanthropies, ("Global Cities"), having its principal office at 1 Rockefeller Plaza, Suite 1134, New York, NY 10020.

WHEREAS, Global Cities is a non-profit organization that has developed "Global Scholars" (the "Program"), an international digital exchange program as described in this Agreement; and

WHEREAS, Global Cities intends to provide all curriculum materials, access to an Internet e-classroom platform and lesson plans required to implement the Program to district coordinators, participating students and teachers; and

WHEREAS, SBBC intends to provide any and all personnel, other services and expenses necessary to access and/or utilize the Program, as described in this Agreement; and

WHEREAS, Global Cities does not intend to charge any fee to the SBBC for providing the Program to the SBBC.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

- 1. <u>Recitals</u>. The parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.
- <u>Term</u>. This Agreement shall commence on July 1, 2019 and terminate on June 30, 2020, unless terminated earlier as provided herein. The term of the Agreement may, by mutual agreement between SBBC and Global Cities be extended for two additional one-year periods.
- 3. Scope of Agreement.

- a. Global Citics shall provide the SBBC with the following materials and services in connection with the Program: (i) coordination with international participants; (ii) training and educational support services; (iii) access to an Internet eclassroom platform; and (iv) curriculum and instructional materials (collectively, the "Materials" and/or "Services").
- b. The SBBC shall be responsible for: (i) any and all costs related to its own personnel: (ii) any taxes, customs, fees, duties, or similar charges with respect to any materials provided to it in connection with the Program; and (iii) the provision of computer equipment and general Internet access required to implement the Program (other than the Materials and/or Services described in this Agreement). In addition, the SBBC shall provide suitable on-site space for the Program's activities, in order to participate throughout the curriculum

- c. The detailed responsibilities of the Global Cities and SBBC are described in the attached Attachment A.
- 4. <u>Global Cities' Representations</u>. Global Cities represents and warrants that (a) Global Cities has the right and ability to provide the Materials and Services under this Agreement; (b) SBBC's use of the Materials and Services will not violate the rights of any third party; and (c) Global Cities has the authority to enter into this Agreement.
- 5. <u>SBBC's Representations</u>. SBBC represents and warrants that it has the authority to enter into this Agreement. SBBC further represents that it is fully accredited by the accreditation authority in the jurisdiction in which the Program will be provided. SBBC shall cause the principal of each Site to execute a letter indicating his or her desire fully to participate in the Program.

## 6. <u>SBBC Disclosure of Education Records.</u>

- a. Global Cities utilizes student information to establish user accounts, including creating passcodes for the e-classroom, joining students to the module topic and connecting students to their teachers. In addition, SBBC students inputting their work and activities in the "e-classroom" enables them to participate in the program.
- b. SBBC will provide Global Cities with the following education records for the purpose listed above:
  - 1) Student first name and initial of last name
  - 2) Username
  - 3) School name
  - 4) School address
  - 5) Student work and activities conducted on Global Scholars program
- c. SBBC shall obtain and maintain the valid and effective written consent of a parent or legal guardian of each student who participates in the Program in the form attached hereto as **Attachment B**. Global Cities shall not post identifying student information to or on any website or e-classroom. Global Cities' use and other processing of personal data in connection with the Program shall be governed by the terms of the consent form in **Attachment B** and shall survive termination of this Agreement. In addition, Global. Cities' use of personal data collected from information provided on its website (www.globalcities.org) will be governed by the Global Cities privacy policy available at that site.
- d. The requirements of this section shall supersede any uses of student information as listed in Global Cities' privacy policies.
- 7. Global Cities' Confidentiality of Education Records.
  - a. Notwithstanding any provision to the contrary within this Agreement, *Global Cities* shall:

1) fully comply with the requirements of Sections 1002.22, 1002.221, and 1002.222, Florida Statutes; the Family Educational Rights and Privacy Act, 20 U.S.C § 1232g (FERPA) and its implementing regulations (34 C.F.R. Part 99), and any other state or federal law or regulation regarding the confidentiality of student information and records;

2) hold any education records in strict confidence and not use or re-disclose same except as required by this Agreement or as required or permitted by law unless the parent of each student or a student age 18 or older whose education records are to be shared provides prior written consent for their release;

3) ensure that, at all times, all of its employees who have access to any education, records during the term of their employment shall abide strictly by its obligations under this Agreement, and that access to education records is limited only to its employees that require the information to carry out the responsibilities under this Agreement and shall provide said list of employees to SBBC upon request;

4) safeguard each education record through administrative, physical and technological safety standards to ensure that adequate controls are in place to protect the education records and information in accordance with FERPA's privacy requirements;

5) utilize the education records solely for the purposes of providing products and services as contemplated under this Agreement; and shall not share, publish, sell, distribute, target advertise, or display education records to any third party;

6) notify SBBC immediately upon discovery of a breach of confidentiality of education records by telephone at 754-321-0300 (Manager, Information Security), and 754-321-1900 (Privacy Officer), and email at privacy@browardschools.com, and take all necessary notification steps as may be required by federal and Florida law, including, but not limited to, those required by Section 501.171, Florida Statutes;

7) fully cooperate with appropriate SBBC staff, including Privacy Officer and/or Information Technology staff to resolve any privacy investigations and concerns in a timely manner;

8) prepare and distribute, at its own cost, any and all required breach notifications, under federal and Florida Law, or reimburse SBBC any direct costs incurred by SBBC for doing so, including, but not limited to, those required by Section 501.171, Florida Statutes;

9) be responsible for any fines or penalties for failure to meet breach notice requirements pursuant to federal and/or Florida law;

10) provide SBBC with the name and contact information of its employee who shall serve as SBBC's primary security contact and shall be available to assist SBBC in resolving obligations associated with a security breach of confidentiality of education records; and

c. *Global Cities* shall, for itself, its officers, employees, agents, representatives, contractors or subcontractors, to fully indemnify and hold harmless SBBC and its officers and employees for any violation of this section, including, without limitation, defending SBBC and its officers and employees against any complaint, administrative or judicial proceeding, payment of any penalty imposed upon SBBC, or payment of any and all costs, damages, judgments or losses incurred by or imposed upon SBBC arising out of a breach of this covenant by the party, or an officer, employee, agent, representative, contractor, or sub-contractor of the party to the extent that the party or an officer, employee, agent, representative, contractor, or sub-contractor, or sub-contractor of the party to the extent that the party shall either intentionally or negligently violate the provisions of this section or of Sections 1002.22 and/or 1002.221, Florida Statutes. This section shall survive the termination of all performance required or conclusion of all obligations existing under this Agreement.

## 8. <u>SBBC Disclosure of Employee Information</u>.

- Global Cities will utilize employee's information to provision and de-provision access to Global Cities' systems, define user roles and permissions within Global Cities' systems.
- b. SBBC will provide the following employee information to Global Cities:
  - 1) First and last name
  - 2) SBBC business email address
  - 3) Name of school the teacher is assigned to
- c. Global Cities shall not: 1) use the employee records listed in this section for any purpose other than listed in this section, or 2) re-disclose the records to any outside source without the prior written consent of the employee, except as required or allowable by law.

## 9. Ownership, Use of Materials and SBBC Contributions.

- a. The SBBC acknowledges that Global Cities owns the Materials and all rights associated with them. All right, title and interest in and to the Materials, including without limitation, any copyright, shall remain with Global Cities.
- b. The SBBC is hereby granted a non-exclusive and non-transferable license to reproduce, display and perform the Materials solely in order to facilitate its

participation in the Program. Modifications or adaptations of the Materials may not be prepared by the SBBC in the absence of a separate, written license from Global Cities. Any use by SBBC of the Materials, in whole or in part, shall in no way affect Global Cities' ownership of and/or copyright in the Materials.

- c. Except as' specifically provided elsewhere in this Agreement, the SBBC shall not knowingly permit anyone other than the SBBC's agents, employees and Program participants to use the Materials.
- d. Except as specifically provided elsewhere in this Agreement, the SBBC may not reproduce, sell, resell, post, transmit or modify any of the Materials.
- e. In no event shall the SBBC use the Materials or Services for commercial purposes, including but not limited to the sale of the Materials or bulk reproduction or distribution of the Materials in any form.
- f. If Global Cities determines that SBBC's use of the Materials is, or may be, detrimental to Global Cities' interest, Global Cities may issue instructions to SBBC regarding the manner in which SBBC may continue to use the Materials. SBBC will promptly comply with such instructions, including but not limited to termination of such use of the Materials.
- g. The parties agree that the SBBC may from time to time provide content or materials created by participating classes, teachers and students ("SBBC Contributions") to be used in connection with the Program, including for postings to the Internet e-classroom associated with the Program. All SBBC Contributions shall be subject to Global Cities' review and approval. Such SBBC Contributions also may be utilized in Global Cities' evaluative processes for the assessment of the Program's effectiveness and utility over time; and such information shall be evaluated on an aggregate basis. By posting any content or materials to the Internet e-classroom, the SBBC grants to Global Cities a non-exclusive license to reproduce, display, modify, distribute, transmit, perform and make derivative works from the SBBC Contributions in connection with the Program or other programs. SBBC further represents and warrants that it has the right to license the SBBC Contributions to Global Cities for these purposes.
- 10. <u>Limitations on Use of Materials and SBBC Contributions</u>. The Parties agree that the Materials and SBBC Contributions shall not be reproduced, displayed, used, performed, modified or adapted by the other party for any purposes except those described in this Agreement.
- 11. <u>Waiver</u>. The failure of a party to assert any of its rights under this Agreement shall not constitute a waiver of such rights. This subsection shall include the right to demand strict performance.
- 12. <u>Termination</u>. This Agreement may be terminated (i) for any reason by either parties upon thirty (30) days' written notice, (ii) in the event of a breach of this Agreement, immediately by the non-breaching party, (iii) upon mutual written agreement of the parties, and (iv) in accordance with any other provisions of this Agreement expressly

- 13. <u>Insurance.</u> Global Cities shall comply with the following insurance requirements throughout the terms of this Agreement: Professional Liability/Errors & Omissions. Limit not less than \$1,000,000 per occurrence covering services provided under this contract.
- 14. <u>No Waiver of Sovereign Immunity</u>. Nothing herein is intended to serve as a waiver of sovereign immunity by any agency or political subdivision to which sovereign immunity that would otherwise apply or of any rights or limits to liability, if any, existing under Section 768.28, Florida Statutes. This section shall survive the termination of all performance or obligations under this Agreement and shall be fully binding until such time as any proceeding brought on account of this Agreement is barred by any applicable statute of limitations.
- 15. <u>Indemnification</u>. Each party agrees to be fully responsible for its acts of negligence, or its employees' acts of negligence when acting within the scope of their employment and agrees to be liable for any damages resulting from said negligence. This section shall survive the termination of all performance or obligations under this Agreement and shall be fully binding until such time as any proceeding brought on account of this Agreement is barred by any applicable statute of limitations.
- 16. <u>No Third Party Beneficiaries</u>. The parties expressly acknowledge that it is not their intent to create or confer any rights or obligations in or upon any third person or entity under this Agreement. None of the parties intends to directly or substantially benefit a third party by this Agreement. The parties agree that there are no third party beneficiaries to this Agreement and that no third party shall be entitled to assert a claim against any of the parties based upon this Agreement. Nothing herein shall be construed as consent by an agency or political subdivision of the State of Florida to be sued by third parties in any matter arising out of any contract.
- 17. <u>Independent Contractor</u>. The parties to this Agreement shall at all times be acting in the capacity of independent contractors and not as an officer, employee or agent of one another. Neither party or its respective agents, employees, subcontractors or assignees shall represent to others that it has the authority to bind the other party unless specifically authorized in writing to do so. No right to SBBC retirement, leave benefits or any other benefits of SBBC employees shall exist as a result of the performance of any duties or responsibilities under this Agreement. SBBC shall not be responsible for social security, withholding taxes, contributions to unemployment compensation funds or insurance for the other party or the other party's officers, employees, agents, subcontractors or assignees.
- 18. Equal Opportunity Provision. The parties agree that no person shall be subjected to discrimination because of age, race, color, disability, gender identity, gender expression marital status, national origin, religion, sex or sexual orientation in the performance of the parties' respective duties, responsibilities and obligations under this Agreement.
- 19. <u>Waiver</u>. The parties agree that each requirement, duty and obligation set forth herein is substantial and important to the formation of this Agreement and, therefore, is a material term hereof. Any party's failure to enforce any provision of this Agreement shall not be
