- 1.01 <u>Recitals</u>. The parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.
- 1.02 <u>Term of Agreement</u>. Pursuant to Section 2.02 of the Agreement, the term of the Agreement is hereby extended from June 30, 2020 to December 28, 2020, unless terminated earlier pursuant to Section 3.05 of the Agreement.
- 1.03 Order of Precedence among Agreement Documents. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:
 - a) this First Amendment; then
 - b) the Agreement.

- 1.04 <u>Other Provisions Remain in Force</u>. Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.
- 1.05 <u>Authority</u>. Each person signing this First Amendment on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment.
