Broward County Schools is the largest fully accredited school district in the United States

School Improvement Waivers are designed to remove barriers to school improvement that have been found in state statute, school board policy, or collective bargaining contract (see School Board Policy #1403). Waivers must be based on sound educational research and evaluation, must be budget neutral to the district, must be supported by stakeholders in the local school community, and must be approved by 66.67% of the faculty. Waivers may be approved for up to five years by the School Board, but the faculty must approve the waiver each year. Waivers must be equitable for all students in a particular student group.

In order to address the challenges and fully implement the vision articulated in the School Board's mission and beliefs, there is a need for accountability at all levels of the organization to improve student achievement and school effectiveness. This policy describes a comprehensive accountability system for the Broward County public school district. Based on the above mentioned policy, Piper High School requests the addition of eight Professional Study Days to provide comprehensive training to all instructional staff that targets specific strategies that will best address student deficiencies that have been identified based on disaggregated data.

8. State the waiver: change, delete, or add to the policy or contract so as to fulfill the requirements of the proposed waiver.

Piper High School requests the addition of eight Professional Study Days for the purpose of providing comprehensive training to all instructional staff.

9. State the rationale for the proposed waiver. How will the proposed waiver support school improvement? Give background information, history of barrier, etc.

Professional Study Days would provide time for specific, comprehensive training for all instructional staff. Training time and days would allow our staff to better meet the needs of all students by providing planning time to review data and plan effective strategies regarding appropriate lesson planning.

10. Recognizing that one strategy alone does not affect school-wide achievement, identify and explain the baseline data for the proposed waiver.

Student achievement data in the accountability areas of ELA, Algebra, Geometry, Biology and US History indicate a need to improve curricular delivery and instructional expertise in order to reach students with learning gaps. Professional development time during regular school days is limited to 30-minute PLC meetings per week. PSD days allow for the effective implementation of school-wide professional development targeting areas of significant student need.

11. What reliable research studies, proven strategies, best practices, or similar programs support the probable success of the proposed waiver?

Consistent instructional contact time has proven to be academically productive for all students. Additionally, training that targets specific instructional strategies as well as classroom management strategies will help to move student achievement forward.

- 12. **Piper High** will evaluate the effectiveness of the waiver each year. Include current data in alignment to the baseline data to measure the impact of the waiver.
