SIXTH AMENDMENT TO EMPLOYMENT AGREEMENT

THIS SIXTH AMENDMENT TO EMPLOYMENT AGREEMENT is made and entered into as of this 23rd day of June 2020, by and between

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "SBBC"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

DOUGLAS G. GRIFFIN

(hereinafter referred to as "GRIFFIN" or "ASSISTANT GENERAL COUNSEL") whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301.

WITNESSETH:

WHEREAS, SBBC and GRIFFIN entered into an Employment Agreement, dated on or about January 22, 2014 (hereinafter "Employment Agreement"); and

WHEREAS, SBBC subsequently amended the Employment Agreement on May 19, 2015, June 21, 2016, June 13, 2017, June 26, 2018, and June 25, 2019; and

WHEREAS, the current term of employment expires on June 30, 2020; and

WHEREAS, the parties mutually desire to extend the term of employment for an additional year as set forth herein; and

NOW THEREFORE, in consideration of the premises and mutual agreements herein provided, the parties hereby agree as follows:

1. **RECITALS.**

The foregoing recitals are true and correct and incorporated herein by reference.

2. <u>EMPLOYMENT AND TERM.</u>

The following should be substituted as paragraph 2 of the Employment Agreement:

SBBC hereby employs GRIFFIN as ASSISTANT GENERAL COUNSEL, and GRIFFIN hereby accepts and agrees to such employment, for an additional year, commencing July 1, 2020 and ending June 30, 2021.

3. **COMPENSATION.**

The following should be substituted as paragraph 4(B):

B. Salary / Compensation. For services rendered by the ASSISTANT GENERAL COUNSEL pursuant to this Agreement, SBBC shall pay to and provide for the ASSISTANT GENERAL COUNSEL the salary and other benefits described in this Agreement.

The ASSISTANT GENERAL COUNSEL's salary for the 2019-2020 school year shall be adjusted consistent with the same percentage and terms awarded to its 12-month administrative employees for the 2019-2020 school year.

4. OTHER PROVISIONS IN EFFECT.

Except as expressly provided herein, all other portions of the Employment Agreement as amended remain in full force and effect.
