Policy 5.5: Attendance

REQUESTED ACTION:
To adopt revisions to Policy 5.5: Attendance at this Final Reading.

SUMMARY EXPLANATION AND BACKGROUND:
The District Attendance Committee convened throughout the 2019-20 school year to align Policy 5.5. to Florida statutes and recommend language to align with best practices. The committee included broad representation of district and school-based staff. The Matrix of Changes addresses all revisions recommended at this time. These revisions were discussed at the May 12, 2020 School Board Workshop, Rule Development, and at the June 16, 2020 School Board Workshop for a first reading. The Regular School Board Meeting on July 21, 2020 represents the final reading. The policy was advertised on June 2, 2020 for the First Reading and June 21, 2020 for the Final Reading.
