EXECUTIVE SUMMARY

Recommendation to Approve First Amendment to the Agreement FY20-093 – Dual Enrollment Articulation Agreement with Florida International University

Introduction

Responsible: Procurement & Warehousing Services (PWS)

This request is to approve the First Amendment to the Dual Enrollment Agreement between The Florida International University Board of Trustees (FIU) and The School Board of Broward County, Florida (SBBC). The Agreement was approved at the Regular School Board Meeting on August 20, 2019, under item EE-3, starting August 20, 2019 through July 31, 2021, with an approved spending authority of \$250,000. Dual enrollment is an acceleration program that allows students in grades 6-12 to take postsecondary coursework and simultaneously earn credit toward a high school diploma, a career certificate, an industry certification, or an associate or baccalaureate degree at a Florida public or eligible private postsecondary institution.

The purpose of this Amendment is to include provisions based on the Florida Department of Education (FLDOE) Emergency Order.

There is no additional financial impact to the District with this Amendment.

Goods/Services Description Responsible: Secondary Learning

The Dual Enrollment Articulation Agreement between FIU and SBBC will provide the opportunity to shorten the time necessary for eligible college-ready students to complete the requirements needed to obtain a degree or certificate. This Amendment to the Dual Enrollment Articulation Agreement between FIU and SBBC will meet the provisions of the FLDOE Emergency Order, 2020-EO-2 dated May 13, 2020. This Emergency Order mandated that the Postsecondary Education Readiness Test (PERT), SAT, ACCUPLACER, and ACT could not be used to determine initial dual enrollment eligibility. The State University System Board of Governors required that institutions develop alternative initial dual enrollment eligibility requirements as detailed in this Amendment.

Procurement Method Responsible: PWS

Pursuant to Purchasing Policy 3320, Section II, H, and the Department of Education, Rule 6A-1.012, 11(b), Florida Administrative Code as authorized by Section 1010.04(4)(a), Florida Statutes, the requirement for requesting competitive solicitation for commodities or contractual services from three (3) or more sources is hereby waived as for the SBBC's purchase of copyrighted materials purchased directly from a recognized educational institution, Florida International University.
