EXECUTIVE SUMMARY

Recommendation of \$500,000 or Less FY21-083 – Construction Printing Services

Introduction

Responsible: Procurement & Warehousing (PWS)

This request is to approve the recommendation to award Invitation to Bid (ITB) FY21-083 – Construction Printing Services for a period of three (3) years from November 1, 2020 through October 31, 2023. This ITB may be renewed for two (2) additional one (1) year periods.

The financial impact to the District will be \$333,000.

Goods/Services Description

Responsible: Office of Facilities & Construction (OFC)

This ITB will be utilized by the Office of Facilities & Construction to procure services for SMART construction projects related to the copying services of architectural blueprints, bonds, and engineered drawings, as well as for optical character recognition and binding services.

Procurement Method Responsible: PWS

This ITB ran from May 15, 2020 through June 2, 2020. One hundred four (104) vendors were notified, and fifteen (15) vendors downloaded the documents. The School Board of Broward County, Florida (SBBC), received five (5) bids of which one (1) is an SBBC certified minority vendor. All five (5) bidders were awarded. The bid was recommended to award all bidders who met all specifications, terms, and conditions of the bid. Vendors who did not submit a bid were contacted to know the reason for not bidding in this ITB. The answers are shown below:
