SECOND AMENDMENT TO AGREEMENT

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "SBBC"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

HOONUIT, LLC n/k/a INFOBASE HOLDINGS, INC.

whose principal place of business is 251 Little Falls Drive, Wilmington, DE 19808

WHEREAS, SBBC and Hoonuit, LLC entered into an Agreement dated June 25, 2019, with a contract term from July 1, 2019 through June 30, 2020 to provide site licensing access for SBBC students, staff, and families through the SBBC portal and Canvas ("Agreement"); and

WHEREAS, SBBC and Hoonuit, LLC entered into a First Amendment to the Agreement on June 23, 2020, to extend the Agreement an additional year; and

WHEREAS, Hoonuit, LLC was acquired by Infobase Holdings, Inc. on July 2, 2020; and

WHEREAS, the parties mutually desire to amend certain provisions of the Agreement through this Second Amendment to Agreement ("Second Amendment") to substitute the name Hoonuit, LLC with Infobase Holdings, Inc.

- **NOW, THEREFORE**, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:
- 1.01 **Recitals**. The parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.
- 1.02 <u>Name Change</u>. Hoonuit, LLC shall be replaced with Infobase Holdings, Inc. ("Infobase"), by interlineation, within the Agreement. By and through execution of this Second Amendment, Infobase agrees to honor and perform the terms and conditions of the Agreement.
- 1.03 <u>Order of Precedence among Agreement Documents</u>. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:
 - a) this Second Amendment to Agreement; then
 - b) First Amendment to Agreement; then

- c) the Agreement.
- 1.04 <u>Other Provisions Remain in Force.</u> Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.
- 1.05 <u>Authority</u>. Each person signing this Second Amendment to Agreement on behalf of either party individually warrants that he or she has full legal power to execute this Second Amendment to Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Second Amendment to Agreement.
