Change Order Items:

Item #1 – (CO #12) IT Improvements – Labor, material, and equipment are required for improvements to the existing IT Intercom system (installation of the supplemental call button system), and Bi-Directional Antenna (BDA) improvements (to allow for improved firefighters radio signals) which were coordinated after permitting, and after the GMP was established. Work includes, but is not limited to, installation of additional call buttons, additional IT outlets, cameras, BDA sleeving, and power upgrades as required and/or necessary. (Owner Request – \$21,885; 0 Days)

Item #2 – (COI #13) New Addition to Service Main Building Disconnect – Labor, material, and equipment are required to relocate the main service disconnect in Building 5 (new building). (Consultant Error – \$10,683; 0 days)

Item #3 – (CO #16) – Existing HVAC Deficiencies – Additional labor and materials to make repairs to the existing HVAC systems due to deficiencies found during the test and balance scope of the contractor. (Owner Request – \$6,612; 0 Days)
