Contract Term: August 19, 2020 through June 9, 2021, Ten (10) Months; User Department: Special Investigative Unit (SIU); Award Amount: \$1,740,000; Awarded Vendor(s): City of Miramar; City of Fort Lauderdale; Small/Minority/Women Enterprise Vendor(s): None.

**SUMMARY EXPLANATION AND BACKGROUND:**  
The School Board of Broward County, Florida, desires to have SRO's to provide security and crime prevention for schools within the jurisdiction of the city agencies.
