## FINANCIAL IMPACT:

The estimated financial impact to the District will be \$257,000. The funding source will come from existing approved schools, departments, and center's budgets. The contract award amount was for \$463,000. The request is to increase the spending authority by \$257,000, bringing the new contract value to \$720,000.
