# EXECUTIVE SUMMARY Termination of Professional Services Agreement LIMCO Engineering Inc. Western High School

## **PROJECT OVERVIEW:**

## **GENERAL OVERVIEW:**

This item is requesting approval of the Termination Agreement between The School Board of Broward County, Florida ("SBBC") and LIMCO Engineering Inc. ("LIMCO") (See Exhibit 2).

The Termination Agreement applies to projects to be constructed at Western High School. The following is a chronology of events that have culminated in this recommended action.

On September 26, 2017, the Parties entered into a Professional Services Agreement ("PSA") for the preparation of design documents and construction administration services for a project to be located at Western High School, Project No. P.001967, (RFQ 17-188C).

# BACKGROUND:

Shortly after LIMCO's projects were initiated, it became apparent that LIMCO was experiencing significant delays in the preparation of design documents for the aforementioned project (hereinafter collectively, the "Project"). In addition, through discussions with Procurement and Warehousing Services (PWS), the Office of Facilities & Construction (OFC) learned of issues surfacing with respect to the relationship between LIMCO and its sub-consultants. In an effort to mitigate any further delays, OFC and PWS met with LIMCO in July 2018 to resolve the concerns. A subsequent meeting was held with LIMCO in August 2018 to discuss recovery actions on the projects. Meetings were also conducted with the Office of General Counsel for guidance.

OFC continued to hold regular meetings with LIMCO from August 2018 through March 2019 to assist LIMCO in improving its response to the deliverables, per the contract requirements, and to determine appropriate action for each of the projects. After multiple meetings between OFC and LIMCO, no improvement had been realized. As a result, it was determined that the best course of action for both parties would be to terminate the projects for convenience in lieu of cause, conditioned upon specific terms set forth in the Termination Agreement. On March 19, 2019, LIMCO agreed to and signed Intent to Terminate letters, and on December 26, 2019, LIMCO executed the Termination Agreement.

At that time, it was decided since the construction drawings were nearing 100% and LIMCO had only one (1) project, the contract for Western High School would remain in place.

Since that time, the Culinary Lab scope of work has been pushed ahead of the rest of the SMART Program Renovations work and is currently being completed. However, the scope of work has been fraught with delays due to the inability of LIMCO to respond in a timely and accurate manner. The drawings for the remainder of the project are still in review by the Building Department.

Should the Board approve this item, it is the intent of OFC and PWS to move forward with the successor Architect and/or Engineer of Record with a recommendation to award at a future Board meeting.

This Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel.

# **EXHIBIT 2**

#### **TERMINATION AGREEMENT**

This Termination Agreement is made and entered into this 3<sup>rd</sup> day of March, 2020, by and between The School Board of Broward County, Florida ("SBBC") and Professional Engineering firm, LIMCO ENGINEERING, INC. ("LIMCO") (collectively, the "Parties").

# WITNESSETH:

WHEREAS, on September 26, 2017, the Parties entered into a Professional Services Agreement ("PSA") for the preparation of design documents and construction administration services for a project to be located at Western High School, Project No. P.001967, (RFQ #17-188C); and

WHEREAS, the preparation of design documents for the aforementioned project (hereinafter collectively, the "Project") experienced significant delays; and

WHEREAS, SBBC desires to terminate the PSA associated with the Project and procure new Architects and/or Engineers of Record; and

WHEREAS, pursuant to the terms and conditions of the termination provisions of the applicable PSA, the Parties have respective rights, duties and obligations which survive termination of those PSAs; and

WHEREAS, the SBBC and LIMCO agree to terminate the PSA for "convenience" in lieu of terminate for "cause," conditioned upon specific terms set forth herein below.

NOW, THEREFORE, in consideration of the foregoing representations, promises and considerations hereinafter set forth with the intent to be legally bound, the Parties hereby agree to the following:

 Incorporation of Recitals: The above Recitals are hereby incorporated into this Reaffirmation as if fully set forth herein.

2. <u>Conditions Precedent</u>: In exchange for SBBC's agreement to terminate the PSAs for the Projects "for convenience," LIMCO agrees to:


- Fully and completely waive its right to seek termination expenses as set forth in Article 10.2.5 of the PSAs for the Projects, and
- Remain liable to SBBC for damages set forth in Articles 10.2.3 and 10.2.4 of the PSAs for the Projects.

3. <u>Continuing Duty to Cooperate</u>: After termination of the PSA, LIMCO agrees to fully cooperate with SBBC and the Successor Architect(s) or Engineer(s) of Record for the Projects. Such cooperation specifically includes, but it not limited to providing documentation to SBBC and/or the Successor Architect(s) or Engineer(s) of Record for the Projects.

4. <u>Termination for Convenience:</u> The PSA for the Project is hereby terminated "for convenience" pursuant to Article 10.2.1 of the PSA.

5. <u>Authority Provision</u>: The persons signing this Agreement on behalf of the Parties individually warrant that s/he has full legal power to execute this Agreement on behalf of each respective Party, and to bind and obligate such Party with respect to all provisions contained in this Reaffirmation.


