#### THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "SBBC"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

### FOX-MAR PHOTOGRAPHY, INC.,

(hereinafter referred to as "PHOTOGRAPHER"), whose principal place of business is 10535 SW 109<sup>th</sup> Court, Miami, Florida 33176.

WHEREAS, SBBC and PHOTOGRAPHER entered into an Agreement dated August 8, 2017 (hereafter "Agreement") for Request for Proposal 17-048N Senior Portraits hereafter "RFP", with an initial contract term from August 8, 2017, and continuing through April 30, 2020; and

WHEREAS, PHOTOGRAPHER is included in a pool of qualified vendors from which school-allied groups might select a vendor to provide such services to students enrolled at a specific district school; and

**WHEREAS**, the parties mutually desire to amend certain provisions of the Agreement through this First Amendment to Agreement (hereafter "Amendment").

- **NOW, THEREFORE**, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:
- 1.01 **Recitals**. The Parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.
- 1.02 **Term of Agreement.** Pursuant to Section 2.01 of the Agreement, the term of the Agreement is hereby extended from May 1, 2020 through April 30, 2021, unless terminated earlier pursuant to Section 3.05 of the Agreement.
- 1.03 Order of Precedence among Agreement Documents. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:
  - a) First:

This First Amendment to Agreement; then

b) Second: The Agreement; then

c) Third: Addendum Number One dated February 17, 2017; then

d) Fourth: RFP 17-048N – "Senior Portraits" dated January 24, 2017; then the Proposal submitted by PHOTOGRAPHER in response to RFP.

1.04 <u>Other Provisions Remain in Force.</u> Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.

1.05 <u>Authority</u>. Each person signing this First Amendment to Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this First Amendment to Agreement.
