SUMMARY EXPLANATION AND BACKGROUND:

<p>Broward County, through the Commission's Office and Children's Service Administration, has been actively involved in the design, vision, model, and implementation of services at Gulfstream Early Learning Center (ELC). As part of the support for the overall Gulfstream ELC project, Broward County Children's Services Administration is allocating \$100,000 to continue funding a site administrator to manage the daily operation services and programs at the site. This amendment extends the funding from the 2019 Agreement and includes up to two (2) additional optional one-year renewal terms.</p> <p>This Amendment to the 2019 Agreement has been reviewed and approved as to form and legal content by the Office of the General Counsel. Broward County will sign this agreement following the School Board approval.</p>
