SUMMARY EXPLANATION AND BACKGROUND:

The program provides an interactive, real-time, and year-round connection that promotes independent, free choice reading. The program is aligned with district reading goals and the Broward Reads Campaign for Grade-Level Reading and provides both the District and schools a method to monitor student time spent reading and quantities of books read. This item will extend the expiration date to June 30, 2021.

EXECUTIVE SUMMARY

Recommendation to Approve First Amendment, Renewal, and Additional Spending Authority FY20-068 – Software to Track Independent Reading

Introduction Responsible: Procurement & Warehousing Services (PWS)

This request is to approve the First Amendment, Renewal, and Additional Spending Authority of the Agreement between Zoobean, Inc. and The School Board of Broward County, Florida (SBBC). The Agreement was approved at the School Board Operational Meeting on June 25, 2019, under item EE-10, starting from July 1, 2019 through June 30, 2020, with an option for one (1) additional one (1) year renewal period and approved spending authority of \$32,712. The Vendor's application provides a digital solution to the District's longstanding reading motivation program "Reading Across Broward," which previously relied on paper and pencil forms printed and submitted annually to schools. This item will extend the expiration date to June 30, 2021.

The additional spending authority being requested is \$32,712.

Goods/Services Description Responsible: Innovative Learning

In 2018-2019, the program was introduced to all traditional elementary and K-8 schools. In 2019-2020, the District expanded usage to include all middle schools. Beanstack is the Fitbit of reading to inform teachers and students about their reading habits and the time spent reading. The program offers a unique gamification platform where students can earn badges to celebrate the number of books read. There is no other product in the District that can provide the same service and appeal to students. Currently, Beanstack supports the BEST standards, which are meant to prepare students to interpret a variety of texts in a variety of formats. During this time of learning in a virtual environment, Beanstack is the perfect complement to student reading using Axis360 ebooks and audiobooks provided through our partnership with the Broward County Library. Students can access books twenty-four seven (24/7) through Destiny Discover then immediately track the book in Beanstack.

Furthermore, schools can create innovative reading challenges to get students excited about reading and to support family literacy activities throughout the entire school year. The application also provides reading recommendations to users which are aligned with the reader's age and interests. Students can also write book reviews within the platform. The software is accessible through the Clever single-sign-on launch pad and can also be accessed on a smartphone using the Beanstack app, providing families an easy and convenient way to track independent reading at home. This program takes the longstanding "paper and pencil" *Reading Across Broward* initiative into a digital format. There is a professional development requirement for the school's media specialist or literacy coach to take in order to be the site administrator for the purpose of generating status reports. Within the two (2) years during the same time frame, there has been an increase of students logging books and the number of books logged (see image below). The District sends out Beanstack data monthly to schools to encourage participation. Schools can also generate school reports to inform how regular reading impacts student achievement.

This first set of data is based on comparing August 15, 2018 – May 20, 2019, to August 15, 2019 – May 20, 2020.

This second set of data is based on comparing August 15, 2018 – March 15, 2019, to August 15, 2019 – March 15, 2020. This time period was selected because it ends right before the start of COVID-19 and the transition to online learning. The District feels that the lift to transition to online learning caused a triage situation, and rightly so. Therefore, teachers, media specialists, and administrators had priorities ahead of Beanstack for this time period, thus skewing usage data. The District is confident (as other districts across the country were looked at), that once students, teachers, and administrators are settled into distance learning and return focus to reading challenges (especially the new year of Reading Across Broward), that usage will continue to increase across the District.

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into as of this day of ______, 2020, by and between

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

(hereinafter referred to as "SBBC"), a body corporate and political subdivision of the State of Florida, whose principal place of business is 600 Southeast Third Avenue, Fort Lauderdale, Florida 33301

and

ZOOBEAN, INC.

(hereinafter referred to as "VENDOR"), whose principal place of business is 4701 Cox Rd Ste 285, Glen Allen, Virginia, 23060

WHEREAS, SBBC and VENDOR entered into an Agreement dated June 25, 2019, with a contract term from July 1, 2019 through June 30, 2020 ("Agreement"); and

WHEREAS, the Agreement provides access to VENDOR's software platform that facilitates independent reading for students throughout SBBC schools; and

WHEREAS, the parties mutually desire to amend certain provisions of the Agreement through this First Amendment to Agreement ("First Amendment").

NOW, THEREFORE, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1.01 <u>Recitals</u>. The parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.

1.02 <u>Term of Agreement</u>. Pursuant to Section 2.01 of the Agreement, the term of the Agreement is hereby extended through June 30, 2021, unless terminated earlier pursuant to Section of 3.05 of the Agreement.

1.03 Order of Precedence among Agreement Documents. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:

- a) this First Amendment; then
- b) the Agreement.

1.04 <u>Cost of Services</u>. SBBC shall pay Thirty-two Thousand Seven Hundred Twelve Dollars and 00/100 Cents (\$32,712.00) for licenses received under this First Amendment to Agreement, within thirty (30) days of receipt of an appropriate invoice as detailed below. The total price represents one hundred eighty-eight (188) licenses at the negotiated price of One Hundred Seventy-four Dollars and 00/100 Cents (\$174.00) per school.

1.05 <u>Amended Provisions</u>. The parties hereby agree to the following amendment to the Agreement:

• The revised Attachment B, attached hereto and incorporated herein, deletes and replaces the original Attachment B in the Agreement.

1.06 <u>Other Provisions Remain in Force</u>. Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.


