TITLE:
Agreements with The Florida Endowment Foundation for Florida's Graduates Inc.

REQUESTED ACTION:
Approve the Agreements between The School Board of Broward County, Florida (as operator of Olsen Middle School and High Schools: Deerfield Beach, Hallandale Magnet, Hollywood Hills, McArthur, Miramar, and South Plantation), and The Florida Endowment Foundation for Florida's Graduates Inc. dba Jobs for Florida's Graduates. The Agreements begin July 1, 2020, and conclude on June 30, 2021.

SUMMARY EXPLANATION AND BACKGROUND:
Jobs for Florida's Graduates is a robust work and life skills development program for middle and high school students who need supportive services to increase their likelihood of high school completion. With these grants, students at seven secondary schools will explore careers, work within teams, develop leadership skills, create and manage wealth, serve their communities, and build a workable plan for their post-graduation life. This grant covers the cost for one FTE position to teach the related course and provide the extracurricular engagement. The School Board approved the grants associated with these Agreements from The Florida Endowment Foundation for Florida's Graduates Inc. on May 19, 2020 (Item EE-1).
These Agreements have been reviewed and approved as to form and legal content by the Office of the General Counsel.

FINANCIAL IMPACT:
