Charter Application Approval - Collegiate Academic Enterprises of Broward, Inc., (The Collegiate School of Lauderdale Lakes)

REQUESTED ACTION:
Approve the application for Collegiate Academic Enterprises of Broward, Inc., (The Collegiate School of Lauderdale Lakes), to open a charter school serving grades K-8 for the 2020 – 2021 school year and authorize the Superintendent to issue a notice of approval. Subsequent School Board approval shall be required prior to the signing of a written charter school agreement establishing the operation of the charter school.
