**SUMMARY EXPLANATION AND BACKGROUND:**  
 Since 1991, The School Board of Broward County, Florida, in partnership with the Broward Center for the Performing Arts (BCPA), has presented the national award-winning Student Enrichment in the Arts (SEAS) Program. The SEAS Program continues to offer a unique style of learning by integrating theatrical performances in dance, music and drama into the student's education. SEAS brings to life storybooks and novels on stage. With COVID-19 in mind, we are collaborating with our colleagues at the BCPA about alternative ways of delivering our traditional SEAS programming.
