## EXECUTIVE SUMMARY Sunshine Academy of Oakland Park, Inc. SunFire High of Ft. Lauderdale - 5401

The original agreement with Sunshine Academy of Oakland Park, Inc. was approved on April 21, 2020, Regular School Board Meeting, Item L-2.

Sunshine Academy of Oakland Park, Inc. desires to amend its charter agreement by changing the school address from 1107 NW 6<sup>th</sup> Street, Fort Lauderdale, Florida, 33311 to 5420-5430 North State Road 7, North Lauderdale, Florida 33319.

The term of the charter shall remain the same, covering five years commencing on July 1, 2020, and ending June 30, 2025.

The Mayor and the City Manager for the City of North Lauderdale will be notified of the change.

SunFire High of Ft. Lauderdale - 5401 is located in District 3.

The governing board members of Sunshine Academy of Oakland Park, Inc., reside in Broward County, Florida.

### FIRST AMENDMENT TO THE CHARTER SCHOOL AGREEMENT

## SUNSHINE ACADEMY OF OAKLAND PARK, INC. d/b/a SunFire High of Ft. Lauderdale

a Florida not-for-profit organization [hereinafter referred to as "School"], and having its principal place of business located at 2360 West Oakland Park Blvd, Oakland Park, Florida 33311.

WHEREAS, the parties entered into a Charter School Agreement ("Agreement") on or about April 21, 2020, which incorporates by reference the School's Charter School Application wherein the School was authorized to operate a charter high school (grade levels 9-12), known as "SunFire High of Ft. Lauderdale" in Broward County, Florida: and

WHEREAS, Section 6.A.1 of the Agreement contains the facility location of the School; and

WHEREAS, the School desires to amend the facility location stated in Section 6.A.1 of the Agreement; and

WHEREAS, Section 2.B.4 of the Agreement permits the amendment of the Agreement during its term through mutual agreement of the parties, provided such modifications are agreed to in writing and executed by both parties; and

- NOW, THEREFORE, in consideration of the premises and of the mutual covenants and terms herein set forth, the parties agree as follows:
- 1.01 <u>Recitals</u>: The foregoing recitals are true and correct and are incorporated within this Charter by reference.
- 1.02 <u>Amendments:</u> The following portion of the Charter School Agreement shall be amended to provide as follows:

### SunFire High of Ft. Lauderdale - 5401 First Amendment to Charter School Agreement

- Section 6.A.1: <u>Facility Location</u>: The new location of the School is 5420-5430 North State Road 7, North Lauderdale, Florida 33319.
- 1.03 Order of Precedence Among Agreement Documents: In the event of a conflict between the provisions of the agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:
  - (a) This First Amendment to the Charter School Agreement; then
  - (b) The Charter Agreement; and
  - (c) The Charter Application
- 1.04 Other Provisions, as Amended, Remain in Force: Except as expressly provided herein, all other portions of the agreement remain in full force and effect.
- 1.05 <u>Authority</u> Each person signing the First Amendment to the Agreement on behalf of either party individually warrants that he or she has full legal power to execute this First Amendment to the Agreement.
