Status of Work:

All scope of work has been completed. Awaiting final inspection for Fire Alarm.

Change Order Items:

Item #1 – (COI #1) Voice Evacuation System Switchover: Fire alarm specification 13845 was updated during construction. Due to update to the specification, the new fire alarm system was required to include the voice evacuation system. (Owner's Request - \$52,305; Add 90 days)

Item #2 – (COI #2) Four (4) Additional Speaker Strobes in the Cafeteria: During final fire alarm inspection walkthrough, it was discovered that the system was not loud enough in the cafeteria. As required by the Authority Having Jurisdiction (AHJ), additional speaker strobes were installed in cafeteria. (Owner's Request - \$4,649; Add 0 days)

Action Plan:

The contractor has provided a time impact analysis to justify the need for the time extension. This change order has been reviewed for entitlement and cost by CBRE | Heery, Inc. and Atkins with a recommendation for approval from CORP.
