and

THE DISTRICT BOARD OF TRUSTEES OF BROWARD COLLEGE, FLORIDA

(hereinafter referred to as "BC") whose principal place of business is 1000 Coconut Creek Blvd., Coconut Creek, FL 33066.

WHEREAS, SBBC and BC (collectively, the "Parties") entered into an Agreement dated June 13, 2017 (hereafter "Agreement"); and

WHEREAS, the parties entered into a First Amendment to Agreement dated September 5, 2018; and

WHEREAS, the Agreement provides an educational support program that establishes a pathway for Non-instructional staff working in Broward County schools to earn a Bachelor's degree in Education, a Professional Teaching Certificate, thus becoming eligible for employment as teachers in high-need areas in Broward County Public Schools; and

WHEREAS, the parties mutually desire to amend certain provisions of the Agreement.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

- 1.01 <u>Recitals</u>. The Parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.
- 1.02 <u>Amended Provisions</u>. The parties hereby agree to the following amended provisions to the Agreement:

The following provisions shall replace the respective provisions in the Agreement, by interlineation, as follows:



- 2.01 <u>Term of Agreement.</u> Unless terminated earlier pursuant to Section 3.05 of this Agreement, the term of this Agreement shall commence upon execution by all parties and conclude on December 31, 2021.
- 1.03 Order of Precedence Among Agreement Documents. In the event of conflict between the provisions of the Agreement and the provisions contained herein, the provisions of the following documents shall take precedence in this order:
 - a) this Second Amendment to Agreement; and
 - b) the First Amendment to Agreement; and
 - c) the Agreement.
- 1.04 <u>Other Provisions Remain in Force.</u> Except as expressly provided herein, all other portions of the Agreement remain in full force and effect.
- 1.05 <u>Authority</u>. Each person signing this Second Amendment to Agreement on behalf of either party individually warrants that he or she has full legal power to execute this Second Amendment to Agreement on behalf of the party for whom he or she is signing, and to bind and obligate such party with respect to all provisions contained in this Second Amendment to Agreement.
